Administrative/Biographical history

Rhondda Borough Council was formed from Rhondda Urban District Council in 1955. The area was served by Merthyr Tydfil Rural Sanitary Authority and Pontypridd Rural Sanitary Authority from 1863, and Ystradyfodwg Urban Sanitary Authority from 1875. In 1894, the latter authority became Ystradyfodwg Urban District Council, which changed its name to Rhondda Urban District Council in 1897. An application was made by Rhondda Urban District Council for Municipal Borough status in 1953. The grant of a borough charter was approved on February 1st 1955, and was presented to the council by the Duke of Edinburgh on April 28th that year. The council officially became a borough, and held its first meeting, on May 23rd 1955.

The Borough Council served the geographical area covered by the Ystradyfodwg civil parish, and parts of Llanwonno and Llantrisant parishes. Its motto was 'Hwy Clod Na Golud' (fame outlasts wealth). The Borough's area of administration grew over the years, and by 1973 it covered 11 wards, with 11 aldermen and 33 councillors.

Rhondda Borough Council held responsibility for housing and recreation. In terms of education, it remained the only 'excepted district' in Wales, and as such continued as the Divisional Executive for education, with Glamorgan County Council acting as Local Education Authority.

Certain health functions were delegated to Rhondda Borough Council by Glamorgan County Council on July 1st 1962, covering environmental health services; personal health services and hospitals. On April 1st 1965 Glamorgan County Council devolved responsibility for weights and measures to the Borough, under the terms of

the Weights and Measures Act 1963. The Borough's main functions in this area were to ensure fair dealings in trade transactions, and to maintain adequate standards. On July 1st 1962, the Borough received a number of welfare services functions from the County Council, including the provision of residential accommodation and the welfare of disabled persons. By 1973, these powers had been removed.

The water supply of Rhondda Fawr was made the responsibility of Rhondda Urban District Council in 1898. This responsibility passed to the Borough Council, which became a constituent member of the Pontypridd and Rhondda Joint Water Board. By 1973, responsibility for water supply had passed to the Taf Fechan Water Board.

Under local government re-organisation in 1974, Rhondda Borough Council became Rhondda (District) Borough Council, one of 6 districts operating under the new county of Mid-Glamorgan. It was the only county that retained its current identity, without merger or part-merger with neighbouring authorities.
