Administrative History: Although an Examination Committee was founded in 1954, the MRCGP exam was only piloted in 1965 (run by a Court later Panel of Examiners). In the meantime, for the years 1952-1966 membership of the College was via the Board of Censors who devised a complicated points based system for assessing applicants for membership of the College. The College exam – the MRCGP became the principle route to becoming a member of the College from 1968. It was initially run by an Examination Secretary (later Chief Examiner, later Convenor) and a panel of examiners (POE). Each examination paper had its own group of examiners who developed it.

Every year from 1968, the examiners held an annual conference to discuss exam methodology and from 1974, they also ran seminars for new examiners.

In 1981, a newly created Membership Division had responsibility for conduct and development of the examination, assessment for the established general practitioner and overseas candidates. It was chaired by John Walker. The Examination Working Party (1982-1986) reported to the Membership Division. The Honorary Examination Secretary of the POE was replaced by the office of Chief Examiner 1981-1987. The role of a convenor elected by examiners was started in 1987. The Examination Board ran the exam 1988-2007 when they were replaced by the Assessment Committee for the new qualification the nMRCGP.

Between 1988 and 1991, there were a series of reviews of the exam by the Centre for Medical Education in Dundee. A computer system introduced in 1989 to Examination Department which meant that every candidate received a breakdown of their marks.

In 1992, some pre-exam tests became compulsory - CPR and CHS [Child Health Surveillance].

By 1996 the exam had two parts - Multiple Choice Questions [MCQ] plus Summative

Assessment: (All trainees to record a single video tape. The accompanying workbook to be divided into two sections. The first section would be completed by all trainees and based upon the assessment method developed by the UK advisers. Candidates who wished to take the MRCGP would also complete the second part of the work book); MEQ [Modified Essay Question] paper of two hours twenty minutes; CRQ [Critical Reading Question of two hours thirty minutes and two oral exams of thirty minutes. The first simulated surgery as part of the MRCGP took place in June 1997. The exam became modular in 1998. In 2007, an entirely new exam nMRCGP became the standard entry to the profession.

The College leant its support to DRCOG, DCH and DCCH, but in 1984, it rejected an offer by the British Geriatrics Society and RCP to join with them in developing a diploma in Geriatric Medicine. Concern was raised in the College about the proliferation of non RCGP diplomas geared towards the general practitioner. A working party looked into this situation in 1989. Papers were presented to May 1990 Council from the Chairman of the Education Division and Examination Board and it was agreed that

- 1. The Core Content of General Practice should be covered by the Membership Examination
- 2. A Distinction could be drawn between the core content and specialist interests
- 3. Specialist Interests of general practitioners could be assessed by diplomas
- 4. The College should examine the possibility of the award of a master's title.

Dec 1990 laid down guidelines for the endorsement of Education Programmes. It also agreed that:

1. The minimum for which the College should settle for should be representation on the controlling body of any diploma with which the College may be working

2. The representative should be sufficient experience in examination techniques, and seniority, to be able to make a useful impact on the methods employed in the diploma.

The subject was further refined by Council Sep 1991 which reiterated the College's view that the College should offer all end point assessment and accreditation in core areas of general practice

and that it should develop and support a framework of assessment both summative and formative which would be required in the future. It agreed that

"The College should seek to become increasingly involved in the work of other organisations providing examinations for established principles with special interests in areas relating to general practice through the identification of examiners their training and the sharing of expertise."

Nov 1993

(a) The College accepted an invitation from the Royal Institute of Public Health and Hygiene to join a steering group to consider the development of a diploma award in Health Promotion/Disease Prevention. and (b) agreed the College would participate in the accreditation of a diploma in Travel Medicine.

March 1997 a new working party was set up to advise Council on future policy on diplomas. It recommended that

The Chairman of the Education Network introduced a paper on the place of diplomas at different stages of a career in general practice. Diplomas tended to be taken in SHO years, Registrar years and post membership years.

(a) in SHO years diplomas should not be mandatory but should not be discouraged where the study undertaken may be beneficial and the is relevant to the career intentions and interests of the doctor;

(b) in the Registrar years, any diploma should focus on training for general practice, ending in sitting the MRCGP Examination;

(c) in post membership years general practitioners should be encouraged to take courses that are appropriate to their higher professional education and are relevant to their career or interests.

From March 1999 the Higher Professional Development Working Group started accrediting Courses including diplomas. [See Diploma in Substance Misuse from 1991-; Diploma in Prison Medicine]

The NHS Plan for England Dec 2000 called for 1000 specialist GP's and the College [Mike Pringle] then started seriously considering the role GPwSI's [CEC/52 Feb 2001] *N.B. [See also Board of Censors minutes and papers ACE F4-11] See also DCCH. The College withdrew from this in 1997*

A CE F 17 Cardio Pulmonary Resuscitation, 1981 - 1997

AN RCP Working Party on Resuscitation (RCGP Representative Judith Fisher] reported in 1987. It considered that during three years vocational training, experience in resuscitation would be considerably limited in certain specialties and in general practice itself. "General Practitioners should attend a course in basic life-support within two years of becoming a principal". It also recommended training of practice staff and the implementation of public education programmes in emergency aid by the general practitioner.

17 Sep 1988 RCGP Council Agreed certificate in CPR became a compulsory pre-requisite for the MRCGP from May 1990. A Working party chaired by Dr Fisher, who was also Chairman of BASICS, was set up to put the requisite procedures in place. Agreement was reached with the Association of Chief Ambulance Officers that Ambulance Training offers were to assess candidates. This was soon widened to include St John Ambulance, Red Cross and A&E or Anesthetists Consultants and later widened to more qualified people such as holders of the Diploma in Immediate Medical Care of RCS [Edin], examiners for St Andrew Ambulance Resuscitation Training Officers, members of BASICS regularly involved in assessing CPR, medical officer in RN Reserve, Territorial and RAF Reserve, medial officers to the fire service.

CPR Certificate was revised from Oct 1993 so that it conformed to guidelines of basic life support working party of the European Resuscitation Council. It was then further revised in 1997.

A CE F 18 Examinations Child Health Surveillance, 1989 - 1995

In the early 1970's the College had a working party with the BPA [ACE N23-1] on the Health

Needs of Children which was published in 1976 and was used as evidence to the Court Report [ACE N27-5] into Child Health Services in 1976 (see also OP 6]. By 1978, the College had formally adopted a policy on child care in general practice which included the statement that every child shall receive "A comprehensive curative and preventative service including child health surveillance through general practice".

February 1989 the Secretary of State announced a new contract and introduced the idea of a child surveillance list. April 1989 the College consulted widely with its members and a special meeting of Council was called "The College will act as the standard setting and examining body for all educational and clinical aspects of general practice"

Guidelines in the Training and Accreditation of GP's in Child Health Surveillance were Jointly Issued by the College and the British Paediatric Association in December 1989. The GMSC was not too happy about this initially as they thought that they should be instructing FPC's rather than the College.

An update was issued in Dec 1990 and again Sep 1991

The Examination Board felt that there was widespread support for the need for important areas of a general practitioner's competence to be examined by general practitioners. Child heath surveillance was identified as part of the core of general practice. There was political pressure for competence in this area to be guaranteed by the MRCGP examination, in fact Child health was seen as a test case for future development. The examination Board did not think it was possible to insert a clinical section on a particular part of general practice into the MRCGP without unbalancing the whole examination. A working party with BPA; HVA; RCN; GMSC report in Dec 1990 on the content of a core district programme for child health surveillance

May 1991 Council agreed that from May 1992 all candidates presenting for the Membership exam should provide evidence of their competence in child health surveillance at the time of application. "Pre-certification will obviate the need to increase the testing time available and the current balance of the exam will be maintained".

Assessors were to be general practitioners undertaking child health surveillance on a regular basis and proved to do so by the FHSA and other doctors currently undertaking child health surveillance under the auspices of a local District Health Authority.

Not all FHSA's accepted the guidelines which led to disparity between regulations applied in different areas (See Council May 1993 C/110 and Nov 1993 C/16

A CE F 21 Examiners Training, 1972 - 1992

In 1977, a new method of selecting examiners was approved. New examiners were to serve for

an initial period of two years with reappointment for a further five years. Examiners had to be members or Fellows who had passed the examination, been a principal for at least five years and are able to devote ten days each year to the panel.

Nominations came from Faculty secretary and current member of the Panel. Nominees then invited to a study day on examination techniques. Those who had not passed the exam had to take it - if they got a grade where an oral was imperative to pass then they could not go any further. If they passed, they had to observe an oral examination and attend an examiners workshop. Only then would appointment be ratified.

Each examiner serves a probationary period of two years, normally followed by an appointment of five years.

In 1996, Roger Neighbour (convenor elect) proposed a shake up of examiner recruitment. "The College is seen by some to recruit its Examiners in a rather "clubbish" way, drawing perhaps too heavily on those with a track record in postgraduate education or vocational training, or on those who may readily command the endorsement of their faculty Boards. He proposed advertising for new members POE with an application pack. Entry to the panel to continue to be on the basis of satisfactory performance on an MCQ, a reduced MEQ and CRQ, and as Assessment Day for PNE. The MCQ should be sat during one of a PNE's day of observing. Convenors should send material pertaining to the drafting and marking of their components before the Assessment day. Time freed by pre-sitting the MCQ and by combining the marking schedule exercise should be given over to a group exercise in marking video consultations. *N.B. See Examiner's file ACE F 20*

It was felt in the late 1980's that the exam was not adequately testing clinical skills [later defined as consulting skills] and in 1990, the Council asked the Examination Board to devise a clinical component for the MRCGP.

After six years of discussions (including with the GMC on the ethics of the videos), trial and pilots the assessment of videotaped consultations was introduced into the MRCGP in October 1996. The candidates were required to submit 4 hours VHS video tapes originally containing 24 consultations but then reduced to 15 including a minimum of two consultations with children under the age of 10 and 2 of chronic disease in adult patients. The candidates were also asked to complete a workbook to accompany their videotape. The assessment of the videos included 11 performance criteria.

In 1998, the MRCGP exam became modular with the consulting skills elements one of the four new modules for most candidates this was still assessed by video tape but for a few candidates this was assessed by simulated surgery [see ACE F27]. The main performance criteria were expanded to 12 with three extra criteria being added which if demonstrated would earn the candidate a "merit" pass.

A CE F 27 Assessment of Clinical Competence or Consulting Skills by Simulated Surgery, 1988 - 1998

Simulated surgery is a technique derived from OSCE (objective structured clinical examination) in which candidates circulate around a number of stations to perform a series of short clinical and paperwork tasks. The aim with simulated surgery is to reproduce as nearly as possible the working conditions of a surgery.

Pilots in using OSCE's were run in 1989 but it was felt that it was more appropriate to use a simulated surgery method. In 1991, a working party was set up to assess how this could be done particularly in relation to scoring methods, reliability and logistics.

The first pilots in simulated surgery were held in 1992-1993 (some as a subcontract to Barts); by March 1993, eight areas of competence had been identified. Reports were written to the Examination Board and the Forum on Assessment. In August 1994, the Forum on Assessment [ACE J31] transferred responsibility for simulated surgery to the Examination Board. In the light of concerns as to the ethics of use of videos by the GMC, the group put forward a proposal in June 1994 for Simulated Surgery to be used as the clinical component of the MRCGP exam. A large scale pilot was held in January 1995. It was proposed to have a Fellow in Simulated Surgery to help prepare to have that element used for summative assessment in 1996.

In February 1997 a formal application was submitted to JCPTGP [Joint Committee for Postgraduate for General Practice] that simulated surgery and assessment by Video [ACE F26] papers count as exemption for the summative assessment. The first simulated surgery as part of the MRCGP took place in June 1997 - 36 candidates applied giving adequate reasons as to why they were unable to provide a videotape of their consultation and 22 did well enough in oral exam to be able to proceed to this stage. By 1998, the MRCGP exam became modular with the consulting skills elements one of the four new modules for most candidates this was still assessed by video tape but for a few candidates this was assessed by simulated surgery.

The Traditional Essay Question [TEQ] paper was renamed the Practice Topic Question [PTQ] paper in May 1984 to allow candidates to use "short notes" instead of a full essay format. It was felt that there was still a need for an "unstructured" paper to test a candidate's depth of knowledge, ability to organise thoughts in a limited area and to test current awareness of "hot" topics and events. The areas that the paper covered were those identified in the "Future General Practitioner" in 1972: Clinical Practice - Health and Disease, Human Development, Human Behaviour; Medicine and Society; The Practice.

At the 1984, Examiners Workshop members of the PTQ panel considered the development of

the paper. David Swanson wrote a report in 1987 "Review of Membership Examination Procedures of the Royal College of General Practitioners" which said that the PTQ questions needed to be more focused and structured and should reward "thought, argument, presentation and written communication". George Taylor of the PTQ panel looking at the future of the paper thought that the marking schema rewarded breadth of knowledge at the expense of depth of ideas. A trial of a "conceptual" marking versus "slacker" was tried in 1988

By 1988, a paper reviewing the PTQ paper was discussed by the Examination Committee and this coupled with critical analysis of the paper in the Dundee report (Mulholland and McAleer Dec 1988) led to a paper by Philip Tombleson going to Council in Sep 1989 which proposed the paper being replaced by a CRQ paper in 1990.

John Foulkes wrote "A Preliminary Analysis of CRQ (Critical Reading Question) paper" in 1992.

The CRQ paper was restructured in 1994 to have 10 questions and two sections (reading/current practice; critical appraisal). Each question was devised (and marked) by a separate subgroup of the CRQ group of examiners. The written papers were changed to happen over two days from 1996 which meant that the CRQ paper was expanded to 3 hours and the pass rate was changed;

"Sustaining the MRCGP Examination: Proposals for the short and medium term development of the Exam" [David Haslam and Roger Neighbour 1997] - proposed a fully modular exam, and that MEQ and CRQ be tested in one paper.

Correspondence and minutes of working group on the meaning of membership (1995) became MAP [Membership by Assessment of Performance]. Includes "The MRCGP Revisited: A Personal View" [Marshall Marinker] (1983) and responses to Council paper on Membership 1981-2. Amendments to ordinance 3.

In 1981, the Board of Censors asked the faculties to consider a proposal for alternative routes to membership than the MRCGP examination as part of a paper to clarify the purpose of the MRCGP examination. The results were published in JRCGP Sep 1981 vol 31 no. 230 pp 521-524. It recommended, "consideration of an alternative route to membership should be deferred until the methodology of performance assessment has been developed and discussed within the College."

1991 motion at AGM to look into issue of alternative routes to membership FBA working group discussed it and Council decided that might be difficult methodological problems in bringing a system of membership equivalent to exam.

1994 Vale of Trent asked Council to reconsider option of Membership by Assessment. Informal discussions were held and in 1995, a Meaning of Membership Working group was set up. It became Membership by Assessment of Performance group by 1996; in 1997, Mersey faculty [John Holden and John Wearne] took over development of project to help to define what aspects of performance and how to assess them - Delphi project.

Administration of MAP moved to Princes Gate when project set up in 1999. MAP finished with 2005 when the route to member and Fellowship of the College was reviewed. It was

succeeded by iMAP [an interim Membership by Performance Scheme which ran 2007-9]
