The following records were deposited on indefinite loan by the Official Receivers in Companies Liquidation, Atlantic House, Holborn Viaduct, London, EC1N 2HD, per A.J. Johnson, Esq., Chief Accountant, Venesta International Packaging Ltd., Langley Road, Pendlebury, Salford, M6 6JP, in May 1981. This deposit was made during proceedings for the liquidation of Venesta International Ltd., a company with which Winterbottom Industries Ltd. had been associated. The registered offices of the Company are given as 12 Newton Street, Manchester, 1, to 1960 and as Barnett House, Fountain Street, Manchester, 2, in 1961.

The first A.G.M. was held in 1893. The directors' report for this meeting noted that manufacturing at Foots Cray, Hoxton and Hackney had been discontinued and business transferred to Weaste and Broughton. At first concerned with the production of book cloth and to a lesser extent tracing cloths, the Company acquired a number of subsidiaries with no connection with book cloth, tracing cloth or other textiles (directors' report, 1955). In 1959 the parent company changed its name to Winterbottom Industries Ltd. and became an investment and industrial management company; its

papers)

former trading activities were taken over by a newly formed subsidiary named the Winterbottom Book Cloth Co. Ltd. By an offer for shares which became unconditional on 11 Nov., 1960, Winterbottom Industries Ltd., became a subsidiary of Venesta Ltd. Winterbottom Products Ltd. became a part of the Tootal Group.

A list of companies (and their products) in the Winterbottom Industries Ltd. Group appears on page 3 of the directors' report issued in 1957. The list includes the following:

Kelly's <u>Directory</u> for Manchester, Salford and Stretford for 1963 gives the address of Winterbottom Book Cloth Co. Ltd. as Victoria Mills, St. Luke's Road, Weaste, and gives a description of it as manufacturers of bookbinders' tracing cloths and glazed hollands for the rubber industries. The same <u>Directory</u> for 1965 gives the same address and description but names the firm as Winterbottom Products Ltd.

On 15 Aug., 1980, Winterbottom Products Ltd. ceased production of bookbinding materials entirely and specialised in the production of reprographic materials which it had begun earlier and on 2 Nov., 1981, its name was changed to Imperial Graphic Products Ltd.; information supplied by a member of staff, 21 Jan., 1983. The address of its head office was at that date Imperial Works, St. Luke's Road, Salford, M6 5RH.
