Mae'r casgliad hwn o bapurau Griffith Jones, cyfreithiwr, Caernarfon, yn ymwneud (yn bennaf) â'r cyfnod 1890-1910, er bod yna nifer o ddogfennau y tu allan i'r dyddiadau hyn. Ymddengys mai prif waith cwmni Griffith Jones oedd trawsgludiadau, morgeisi a phrydlesi. Er bod nifer helaeth o ddogfennau unigol yn y casgliad, fe erys olion o'r dull gwreiddiol o ffeilio, lle rhoddwyd dogfennau o'r un fath (â phob un â'i rhif unigol) mewn bwndeli yn nhrefn dyddiad. Felly, ceir bwndeli o drawsgludiadau drafft yn unig, eraill yn cynnwys prydlesi, morgeisi, aseiniadau, ewyllysiau ac yn y blaen, gyda bwndeli ar wahân ar gyfer pob math. Mae'r system hwn, er yn ansoffistigedig, yn ddigonol ar gyfer y prif gategorïau o ddogfennau, ond daw anghysondeb ac amyfusedd i'r fei lle ceir mân fwndeli o fathau anghyffredin ar ddogfen, megis affidafidion, sy'n ymdrin â materion mor amrywiol â dyledion, gweinyddiad ystadau a hawliau i eiddo. Serch y gwendidiau hyn, mae'r bwndeli gwreiddiol wedi eu cadw yn y rhestr a ganlyn, er mwyn parchu egwyddorion archifol.

This collection of papers of Griffith Jones, solicitor, Caernarfon, deals in the main with the period 1890-1910, although there are a number of documents from other periods. It appears that the firm of Griffith Jones was concerned primarily with conveyancing, mortgages and leases. Although there is a large number of individual documents in the collection, the remains of the original filing order are to be found : documents of the same type, each individually numbered, were bundled together in date order. Thus bundles comprised solely of draft conveyances are to found, as are bundles of leases, mortgages, assignments, wills and so on, each type being bundled seperately. This system, although unsophisticated, worked well enough for the main categories of document, but inconsistency and confusion arise where small bundles of uncommon types of document are concerned; for example, affidaints, which treat matters as varied as debt, probate and rights to land. Despite these weaknesses, the original bundles have been preserved in the following list, in order to respect archival principles.
