Captain William Thomas (1822-1893) was the son of Lewis Thomas, Cae Pant. By 1858 he was involved in shipbuilding and by the mid 1860s was managing more than a dozen vessels. By 1870 he was living at Ponc Taldrwst and the owner of a warehouse and yards at Amlwch Port. By 1872 he had bought the Treweek yard and dry dock and had a ship chandlery business and close connections with Duddon/Millom in Cumbria and William Thomas of Liverpool (born Llanrhuddlad). In the 1880s the firm base established by Captain Thomas was expanded and developed by his sons William (who had trained as a naval designer) and Lewis. The collection also includes family papers including documents about Bryn Eilian and other family business interests. Some documents cover both the shipping business and the household.

[The majority of the documents are badly damaged by previous damp storage].
