#### **Introduction**

H. Hall & Son was established in 1836, as a Shipping and Insurance Agent. In 1964 the business was bought by Mr. D.G. Young, Jersey, who appointed Mr. Peter N. Ellis as Manager. In 1967 Mr. Peter N. Ellis took over the business and the trading name was changed to Halls Travel Agency. In 1993 Veronica Hill, who was the daughter of Mr. Peter N. Ellis, became a partner. The business closed at the end of April 2001. Mr. Peter N. Ellis donated the collection in June 2001.
