Edwards Geldard and Shepherd are a major solicitors' practice established *c.* 1969 by amalgamation of older practices of C and M Edwards, Shepherd & Co, and Alan Pratt and Geldard. Charles and Martin Edwards were successors to the practice established by C.E. Edwards at 16 St Andrew's Crescent, Cardiff, in 1893. Pratt and Geldard derive from the practice of Cyril J. Geldard in Mountstuart Square, Bute Docks, in 1914.
