### **Administrative/biographical history**

Cardiff Hotels Co was incorporated as a private company in 1898 to manage the Royal Hotel, St Mary Street, Cardiff. It went into voluntary liquidation in 1935 and its assets were taken over by Ind Coope and Allsopp Ltd of Burton on Trent, later Allied Breweries.

Ind Coope also owned or managed other public houses in Glamorgan.
