Administrative/biographical history

Groundwork Bridgend & Neath Port Talbot was formed in 1989 as Ogwr Groundwork Trust. It is an environmental regeneration charity working towards sustainable development in communities in need of investment and support.

Based in Bridgend at Parc Tondu, a refurbished Victorian ironworks, the Trust has three core business aims: Community Regeneration, Environmental Regeneration and Sustainable Regeneration. Working in partnership with local communities and the public, private and voluntary sectors, the Trust's projects have helped regenerate some of the most deprived areas of the South Wales valleys through innovative and relevant projects that effectively address the needs of the communities its works with.

Groundwork Bridgend & Neath Port Talbot is one of four Groundwork Trusts in Wales, the others being: Groundwork Caerphilly; Groundwork Merthyr & Rhondda Cynon Taff; Groundwork Wrexham and Flintshire. Groundwork Wales was established in 1998 to lead and support the collective operation of the Welsh Trusts; it is one of the regional branches of Groundwork UK.

Groundwork grew from a Government-backed experiment initiated by the Countryside Commission to find new ways of improving the environment on the edge of industrial towns and cities. The first Groundwork Trust was established on Merseyside in 1981 to run the first practical projects, working in conjunction with the local councils, local businesses and other voluntary bodies to realise the full potential of under-used land, to convert waste ground to productive use and to improve access to the countryside. By 1983, Groundwork Trusts were operating across England, and the first Trust was established in Wales - in Merthyr Tydfil. In 1990, Groundwork expanded its work to include inner cities and town centres and began concentrating on supporting people and businesses in deprived neighbourhoods. As the scale and scope of its projects increased, the Groundwork Foundation (now Groundwork UK) was established to co-ordinate the work of the regional Trusts. Groundwork now operates in Northern Ireland, and is also involved in projects and partnerships across Europe.

The records remained with the Trust until deposit.

Immediate source of acquisition

The collection was donated in February 2008 after being rescued by a landscape architect working at the Trust as it was about to be destroyed.

Scope and content

Includes files relating to the planning and execution of environmental and community projects undertaken by the Trust, as well as the records of one of its environmental artists, Dilys Jackson. There are numerous photographs of community and school projects and of the local environment.
