By the end of the 1880s he had founded, and frequently acted as Secretary and Director of, the Cardiff Exchange and Office Co. Ltd. and the Glamorganshire Workmen's Cottage Co. Ltd., whilst holding substantial interests in the Cardiff High Street Arcade Co. Ltd, Avoca Estate Co. Ltd., Barry Island Cottage Co. Ltd., Whitefield Estate Co. Ltd., and Weston Hill Estate Co. Ltd.

He continued to play an active part in these and other companieS until his death on 27 Mar 1940
