Cynon Valley District Council was formed in 1974 from Aberdare Urban District Council and Mountain Ash Urban District Council with the addition of Penderyn Civil Parish taken from Vaynor and Penderyn Rural District Council (1896-1974). Cynon Valley District Council was abolished in 1996 and most of its powers transferred to the new unitary authority Rhondda Cynon Taf County Borough Council.
