CONTEXT

Administrative/Biographical history: Prior to Mr D. T. Alexander entering into partnership with Mr W. P. Stephenson, Mr Stephenson had been in partnership with a Mr Watkins, who started practising in Cardiff, Glamorgan, either at the end of the 18th century or the beginning of the 19th century. Alexander had been involved in practising from Pontypridd, Glamorgan, in his own right as auctioneer from the mid 19th century. In 1877, D. T. Alexander and W. P. Stephenson formed Stephenson & Alexander; prior to that date, the firm had been known as Watkins & Stephenson. W. P. Stephenson died in 1885, and Alexander became head of the firm. Early in the 20th century. Alexander's sons, John and Hubert, joined him in the firm, and in due course became his partners. Up to his death in 1921, D. T. Alexander was still practising within the firm. The sons continued in their father's footsteps, and became more involved with landed estates, mainly across south Wales, but also in the West Country. In 1937, Hubert Alexander's son, Duncan, joined the firm, but with the intervention of the Second World War the running of the firm was left entirely to John and Hubert Alexander. Immediately after the war, Duncan Alexander became a partner, and in the 1950s, his younger brother, Peter, also joined the partnership. After the deaths of John and Hubert in 1954, the firm was run entirely by Duncan and Peter until the late 1960s, when William ('Bill') Hunt, who had been an employee of the firm since 1952, was appointed as partner. In 1976, Hugh James, who joined the firm in 1961, and David Davies, who joined the firm in 1968, were made associate partners. David Davies became a full equity partner in 1980, and Duncan and Peter Alexander in 1988. Hunt died in 1995; his brother-in-law Peter Graham, Local Director of DTZ Debenham Thorpe in Cardiff, then joined David Davies as a partner. In January 1999, Jason Jones, who joined the firm in 1989, was appointed as associate partner.
