## CONTEXT

**Administrative/Biographical history:** The solicitors firm of Stockwood of Bridgend, Glamorgan, was founded by Thomas Stockwood (1814-1895). He was joined in the business by his clerk, J. H. Williams, and the firm's name was changed to Stockwood and Williams. The firm's clients included the Rev. Thomas Davies of Coity, the Lewis family, and the Phillip Price Trust and Price Davis family.

## CONTENT

**Scope and content/abstract:** Records of Stockwood of Bridgend, 1614-1918, including: papers of the Rev. Thomas Davies of Coity, and Coity parish lease of property, 1767-[c. 1914]; correspondence, reports etc, relating to 'The Rest', Newton Nottage, 1863-1884; mineral estate papers and lease of Crythan Park Estate, Melincrythan Estate, Llynvi Colliery and Duffryn Pit, and letters relating to the 1873 strike, 1870-1881; poems of local interest, 1806-1861; political poems about taxes, 1808; papers relating to the Lewis Family, 1815-1888; Glamorganshire Rifle Volunteers papers, 1861-1887; correspondence, [c. 1819]-1918; miscellaneous papers, 1808-1871; deeds, contracts and sale catalogues, 1844-1927; Manor of Coity Anglia papers, 1728-1914; papers relating to the Phillip Price Trust, 1733-1943; papers connected with the administration of the Phillip Price Trust, 1842-1948; estates of families for whom Phillip Price (and others) acted as trustees, 1825-1875; estates of members of the Price Family; 1847-1913; and estates of members of Price Davis Family (descendants of Phillip Price), 1876-1938.

## ACCESS AND USE

**Language/scripts of material:** English, Welsh, Latin and French; hand-written and printed.

**System of arrangement:** Arranged according to date and type.

**Conditions governing access:** No restrictions. These records are stored in an outside repository. They should be ordered at least a week in advance of an intended visit so that they can be brought into the Record Office for consultation in the search room.
