Between (!) Lawrence Campe Citizen and Draper of London,

and (2) The Churchwardens of the Parish Church of St. John Upon the Walbrooke, London.

- Recites (1) that Lawrence Campe had erected 6 almshouses in a place called Thromers, Friern Barnet, Middx., for the free harbour and dwelling of 12 persons or more for ever;
 - (2) that £15 yearly rent from that Meadow called Wild Marsh of 23 acres and Horse Leys of 10 acres being in the parish of All Hallows, Herts., confirmed to the Churchwardens and their heirs and assigns of St. John Walbrooke.
 - (3) Annuity to be used as set out in Schedule annexed to the Indenture.

Abstracted by Paul Wicks of St. Johns St. Scrivener who hath the said Indenture in his custody having purchased of the heirs of the said Mr. Campe the said Meadow grounds out of which the Annuity is payable.
