The archival provenance and order of these MSS is lost.

Almost all (and probably in fact all) belonged to Major N. Brett-James, who endorsed them with his own reference numbers, but how or when he acquired them is unclear. There are some relevant references in file MS 12,248. This includes a receipt signed by F.G. Emmison (subsequently Essex County Archivist) in 1932 for 13 deeds, which include 8 listed here: now MSS 2425, 2428, 2432-7. 2 more of the 13 are now accessioned as MSS 2307/1 and 8683, and the remaining 3 are not yet indentified. In 1935 Major Brett-James made a large donation to the library including 75 local deeds, and most or all of these items may be included with it, as are also MSS 2307/1-25.

Some of the items listed here have attached printed catalogue descriptions suggesting that Major Brett-James purchased them at auction. Again the date(s) and grouping(s) are lost, and are not preserved by Major Brett-James' own reference system. Both original and Brett-James references are listed where they occur.
