The right to make 2 fishponds granted. Reservation of timber. Conditions concerning repair, etc. Term: 3 years and then from year to year. Rent: £240 and £20 for every acre converted into tillage. 1 March 1840.

£20 for the realese of poor prisoners out of Ludgate and the Two Compters in London.

£25 to his kind mother, Susan Trott..

£5 to the eldest daughter of Thomas Trott of Richmond, the wife of Raphe Wycliffe and the rest of the children of Thomas Trott.

£20 to his sister, Hester, wife of Ellice Day.

£3 to his maidservant Dorothy Sharpe.

£1 apiece to 3 other maidservants.

£3 to John Downes his servant at Colney Hatch.

£5 to Richard Garbrand his apprentice.

£100 to Robert Campe, at the expiration of his apprenticeship if he lives in London, not in the country.

£5 to his godson Lawrence, son of Symeon Richardson, on attaining 21 years.

£5 to Sibbill, widow of Thomas Thresher.

£3 to Elizabeth Wesley, his late wife's sister.
£5 to his cousin Jane Goodale at Colney Hatch and 12 pence weekly for life.
40 shillings to Goodwife Cooper, Jane Goodale's sister.
40 shillings apiece to his neighbours Richard Alleston, William Clarke, and Owen Davis.
£10 to Robert Meakins, Preacher at St. John's in Walbrooke.
£40 to poor scholars of Cambridge University.
£14 to the Company of Drapers for a dinner.
£6 for the maintenance of poor children in Christ's Hospital.
£1 to the poor of Fryerne Barnett on the day of his burial.
£1 to the poor of Alhallowes in the Wall.
£1 to the poor of St. John in Walbrooke.
Great seal ring of gold to his son Lawrence.
A treble sovereign of gold to each of his four daughters.
£10 p.a. and bed and board to his brother Thomas.
The residue of his goods to his wife Judith, his executrix.
Overseers to be John Trott and Robert Meakins.
£20 to each overseer.
£10 to the man who settles the wardship of his son.
Annuity, as given by deed, to be paid to Alhallowes in the Wall.
Messuage in St. John upon Walbrooke to be to the uses mentioned in the deed.
The annuity out of Wild Marshe, Herts, to be used according to the deed.
Lands and tenements in Fryerne Barnett held by his daughter, Susan, to be enjoyed by her, except the land allotted for the use of the Almshouse.
Lands and tenements in Chipping Barnet held by his daughter, Jane, to be enjoyed by her.
His lands and tenements in Finchley to his daughter, Judith.
Tenement, house and lands in Finchley, bought of Joane Rolfe, to his daughter Elizabeth.
£1 p.a. to the Beadle of the Ward of Walbrooke.
The rest of his lands and tenements to his son, Lawrence.
