MINUTE BOOKS OF THE LONDON CORINTHIAN SAILING CLUB  
1894-1940

Deposited by Mr D B Widdowson, Vice-Commodore, on behalf of the  
London Corinthian Sailing Club, 20 November 1975.

The Corinthian Sailing Club was established at a meeting on 20  
October 1894, its object being "to encourage the building,  
sailing and racing of sailing boats." The station was Black Lion  
Stairs, Hammersmith. Originally, the club met in rented rooms  
at 19 Lower Mall, Hammersmith, and also at the Lowndes Arms,  
Lyall Place, Eaton Square. In 1896 the club acquired the  
premises in Lower Mall formerly occupied by the London Sailing  
Club, and, from January 1897, became known as the London  
Corinthian Sailing Club. In the early 1960s the club premises  
moved to Linden House, Upper Mall, where it remains to date.
