There is an embargo of 20 years on the production to members of the public of the records catalogued below.

The following information has been supplied by Mr. H.H. Johnson. This business was founded by John Erlam Winstanley, clerk and assistant overseer of Partington Parish Council and brother-in-law of Ezekiel Hampson, a Councillor of Irlam Urban District Council. Winstanley maintained the business until c.1909 when it passed to his stepgrandson-in-law, Bertrand Johnson (usually known as Bert Johnson), father of Mr. H.H. Johnson. The address of the business had been 156 Liverpool Road but B. Johnson built 154a Liverpool Road, which he used as the address for his business. (His wife conducted a greengrocery business in the premises adjoining 154a Liverpool Road). In March, 1917, he sold the business to Frederick Taylor who carried it on from an address close to the building now housing the Trustee Savings Bank, 90 Liverpool Road, Cadishead. In 1924 B. Johnson bought back the business. He maintained it from Limefield Farm until c.1930 when it was moved to 4 Liverpool Road, Cadishead, for a year, later to 23 Liverpool Road, Cadishead, and in 1938 to 175 Liverpool Road, Cadishead, where it stayed until his death in 1946. There was also for a time a workshop in Fairhills Road, Irlam. On his death the ownership of the business passed to his widow though it was carried on for her by Mr. H.H. Johnson. Two years before her death in 1958, ownership was transferred to Mr. H.H. Johnson and continued with him until his retirement on 30th. Sept., 1977.
