### Records of

The Wellingborough Boot and Shoe Manufacturing Co. Ltd.

Manufacturers of Sports Footwear, Herriotts Lane, Wellingborough.

Accession 1978/10

The Wellingborough Boot and Shoe Company was founded in 1891 by a group of local businessmen, to manufacture men's boots and shoes in premises in Herriotts Lane, Wellingborough. These premises, which occupy half of the present site of the factory, included the use of an old chapel which became the closing room. Mr. Morgan, a solicitor of Silver Street, Wellingborough became the first Managing Director. In 1907 he became Chairman and Mr. Sharp became Managing Director, with Mr. Beale as Company Secretary. It was in this year that the business became a Limited Company, changing its name to the Wellingborough Boot and Shoe Manufacturing Company Ltd. At this time the building was also enlarged to its present size.

By 1919 Mr. Beale had died and Mr. Saddington, the Managing Clerk at Mr. Morgan's firm of solicitors, became the Company Secretary, Mr. Warren had become Chairman and Mr. Rowe, who joined the Company in 1913, was Manager.

During the first World War, heavy army boots were made, however, during the 1920's the Company suffered a period of depression. More shoes were then made than boots, as boots went out of fashion about 1925. Mr. Rowe saved the Company from the worst of the depression by introducing the manufacture of football boots. Ordinary boots were still made, notably black and yellow boots sent to the West Coast of Africa.

About 1930 Mr. Sharp died and Mr. Rowe became Managing Director of the Company. He built up the production of sports footwear, introducing cricket boots and very cheap men's footwear.

The factory was requisitioned by the Ministry of Aircraft in 1941 and the Company therefore moved in with Glover Bros. of Stanley Road, Wellingborough, where they produced some troop footwear, utility footwear and a restricted amount of football boots. The Company did not receive their Herriotts Lane premises back until 1947, when the building received alterations to modernise it. After the war, Mr. Rowe became the Company's Manager and subsequently, Managing Director and Chairman.

Mr. Rowe was Chairman until 1958 and then Mr. Warren became Chairman until his death in c.1965. The present Chairman, Mr. J. Idiens and Director, Mr. G. Little are both sons-in-law of Mr.

Warren, who was the grandson, by marriage, of one of the original founders of the Company, a Mr. Neale, a farmer from Twywell. The current Managing Director is Mr. G. Jones.

The Company is notable for its long serving employees, Mrs. A. Clarke, who joined the Company in 1919 in the office, later becoming Company Secretary and a Director, retired after 55 years service in 1974. Mr. Tom Roberts, who joined the Company in 1910 working on the production of shoes, retired in 1971 after 61 years service.

Today the Company produces sports footwear, mainly training shoes and football boots.
