#### ROOPER MSS.

These papers relate to George Rooper (died 1905) of
Nascott House, Watford, and his executors, Henry Napier Rooper,
and Whateley and Moore, all London solicitors. In 1884 Rooper
acquired the Llanerchrugog Hall estate from Thomas Jones, with
industrial interests. The estate included minerals at
Llwyneinion which were leased to J.C.Edwards of Trevor Hall, Ruabon,
brickmaster, and to Powells, brickmasters of Buckley.

Thomas Jones also owned Pant Glas and Tan-y-Graig farms, Llangollen and in 1883 the Pant Glas slate and slab quarry company was formed to develop the land at Eglwyseg. The papers of the company solicitors, Francis Rooper include extensive correspondence with company directors and major shareholders and with the quarry manager. Several documents refer to a proposed tramway by means of telpherage. (overhead electric lines).

A number of items relate to the sale of the estate following 1905. Sale papers for Llansantffraid Glynceiriog refer to the Wynne slate quarry and to houses in Nascott Terrace.
