O'MAHONEY PAPERS (1909-1946)

Timothy O'Mahoney was born in Newport of Irish parents, who settled there in 1877. He attended St. Michaels School for a time and when of working age, studied in the evenings under the Rev. Edgar Williams, M.A., B.D., Principal of Maindee College. He took a special course of training to qualify for a scholarship examination for Dublin University - as something to work for and continued his studies in mathematics, Latin, Greek, French and the English Classics until the death of the Rev. Williams. His first employment was in the works at Isca Foundry with his father and later in the stores department. In about 1906 he became permanent Way Stores Clerk for the Alexandra Dock Company in Newport. In addition to his own studies he coached pupils for London University, the Civil Service and other examinations.
