The Monmouthshire Bee Keepers Association was founded in 1918. Prior to its formation, there had been several unsuccessful bee keepers societies in the county.

The Association became affiliated to the British Bee Keepers Association, and continued to run through the Second World War.

At the Annual General Meeting in 1974 it was decided that the name be changed to the Gwent Bee Keepers Association, in keeping with the re-named county.
