His salary was £8 per annum with leave to keep 5-6 brood mares, 6-7 cattle and 40-50 sheep to enable him to make another £50 per annum. He was steward for over 8 years. During this time William Bodvel received the rents but as he was engaged with frequent visitors he often forgot to give receipts. While he stayed in London the money was sent to him either by bills of exchange or by drovers driving cattle from Caernarvon to London. These drovers were not given personal interviews but paid over the money to his agent or

servants. Again the servants did not give receipts. In order to settle the accounts Hugh Williams, clerk, domestic chaplain of William Bodvel, took custody of all the accounts, receipts, etc. and refused to surrender them. Richard Bulkeley on death of Richard Coytmore used his influence to present Richard Edmund his own nominee to the living in 1727. Joseph died soon after leaving Rice Thomas his heir and only son as owner of the advowson, then an infant. He insisted on keeping part of the money to indemnify himself against dower until Jane late wife of Owen Lewis, deceased, now the wife of William Owen of Bodeilio, co. Anglesey, yeoman, released her claim to dower.

Jane later pressed her claims for dower. John Owen agreed to pay £40 dower and borrowed the sum from William Prichard promising to execute a further mortgage. He later refused to execute this mortgage or to pay the balance of the purchase money to Owen Lewis. They seek for redress.
