A SHORT BIOGRAPHY OF JOHN WILLIAMS

This catalogue covers the papers accumulated by John Williams, solicitor, of Caernarfon, and which relate to pubic bodies in the Caernarfon area. Some of the documents relate to various public and voluntary offices held by him and others appear to have been acquired by him out of historical interest.

John Williams (1882-1964), son of Captain Robert Williams was born in Port Dinorwic but moved to Caernarfon with his parents at an early age. He practiced as a solicitor with W.T.Henwood and Co., Market St., Caernarfon and retired just before the Second World War Among the offices held by him at various times in his life were Town Clerk of Caernarfon, Clerk to Co. Caerns, sanitary committee, secretary of Llanbeblig Parochial Church Council, Hon. Secretary of Caernarfon Church Guild and Acting Returning Officer. He was a member of the Church of Wales. He had a keen interest in local history and was considered something of an expert on the history of the town.

During the first world war he was a captain in the Royal Welsh Fusiliers in France. He was responsible for making the arrangements for the burial of Hedd Wyn who was killed in action in 1917.

In 1937 he was responsible for the arrangements during the visit of King George VI and Queen Elizabeth to Caernarfon.

NOTES ON CATALOGUE: This list is divided into 9 subgroups (see next page for subgroup listing). Introductions have been provided to the larger subgroups but the smaller subgroup entries are self explanatory. Most of the subgroups divide into classes (eg. MINUTE BOOKS, MAPS etc). Introductions to classes have only been included where the general subgroup introduction, class title or item descriptions do not supply enough information to assist the searcher. A few of the subgroups consist of only a small number of items and have, therefore, not been split into classes.

XD11/1 1784-1831 ST. MARY'S CHURCH, CAERNARFON

St. Mary's Chapel dates from the early 14th century. The Church was built against the town walls and the tower at the North-West corner of the walls became the church vestry. The church still remains in use although it has been heavily restored and altered.

The papers in this collection date from 1784-1831, although the bulk of the collection is formed by papers from 1800-1814. By the late 1790's the church had become too small to hold its congregation and was also badly in need of repair. The Caernarfon Chapel Act was passed in 1800 and was gifted to the town by the Earl of Uxbridge. The act required that Trustees be appointed. Owen Poole, Solicitor was appointed clerk to trustees. The proposed methods of finance were to be sale of pews in the rebuilt church, subscriptions and some funding from Caernarfon Corporation. Unfortunately the attempt at rebuilding had to be abandoned when costs proved to be prohibitive.

It was not until 1810 that rebuilding was again considered. A Committee for the Repair and Improvement of St. Mary's Church was set up. Again the methods of finance were to be sale of pews, subscriptions and Corporation funding. A plan by Benjamin Wyatt was approved and advertisements were placed in newspapers for estimates from architects. John Dale was appointed as overseer of the building work and contracts were entered into with various tradesmen and suppliers. A committee was set up to decide on the valuation and allocation of pews in the rebuilt of St. Mary's Church. The new church was finally completed on Feb. 20 1814.

The majority of papers in this particular part of the collection are those relating to Owen Poole.

It also includes several written and printed electoral lists dating from the 19th century to 1931. Probably the most notable document is XD11/9/15 which includes a declaration by David Lloyd George against an objection to his inclusion in the electoral register. Another document which deserves mention is XD11/9/81 which appears to be an 18th century List of Burgesses in Caernarfon. John Williams was Acting Returning Officer for Caernarfon District of Boroughs during the 1929 general election.
