A collection of records relating to the affairs of the Caernarfon Wesleyan Circuit before it joined with the Bangor and Tregarth Circuits to form the Arfon Circuit in September 1974. Also a few papers relating to the Arfon and Llanberis Circuits (for a short period c.1872-1880 Llanberis was a separate circuit). Deposited by the Rev. A.W. Francis, Circuit Superintendent.
