ship load a far smaller cargo than her capacity, but also the Captain sent no certificate of delivery, so they were unable to claim due payment from their buyer. In the circumstances they have decided to pay £25 in order to settle the dispute amicably.

TSW concludes irritably: "We paid an extravagant price for the W.W. Lloyd outwards and did not make even a brokerage on the homeward charter. The ship has made a splendid voyage at our expense."

LETTER (Copy): Owen Lloyd, Porthmadog, to Messrs T.S. Whitehead & Co. acknowledging the receipt of the cheque for £25. He accepts this sum in full settlement of the balance of outward freight of W.W. Lloyd from Tyne to Siciy "rather than have any further unpleasantness." He regrets that TSW lost money in the transaction and trusts that they will have better luck in future.

She hopes to come home and says "the journey from here is nothing now-a-days its only a matter of thirty five or forty days with these swift steamers."

They are going to have a grand International Exhibition opened at the end of August. She mentions her daughters Kate and Jane; Kate will soon be going to school. She had been to see the unveiling of Captain Cook's statue. She sends their love to all the family "not forgetting my old cariadau Owen and David." She is writing to Uncle William per same mail and asks to be remembered to her "dear old mother."

describes the problems of the voyage in great detail: a leak which necessitated continuous pumping; a sailor backing out; administrative delays; having to pay a Tug £5 to tow them out from Southend; appalling gales; the loss of several sails; inaccurate chronometer readings etc. However they have had no serious damage, only wear and tear.

LETTER: Owen Griffith, at Pernambuco to Capt. Lloyd. He describes the attempts he has made to find a profitable cargo for the return voyage: salt was offered at 14s. per ton; sugar at 15s per ton and cotton at 15s, all of which he rejected. He has waited for the arrival of today's mail from the West Indies but has seen nothing worth sailing to Barbados for. As a result he has finally come to an agreement for a cargo of cotton seed at 30s per ton, which he assures Capt. Lloyd is the best he is likely to do. He will stow it down very hard and expects to carry at least 320 tons. OG hopes this will be satisfactory and complains that it has been a hard task with so many vessels to compete with.
