LLYTHYR : John Owen, Welsh Church, Talbot Street, Dublin at Mr. Williams yn trafod busnes prynu y tai yn Stryd Talbot. Ar ôl ymddiddan a'r brodyr barnwyd mai gwell fyddai peidio sôn yr un gair wrth y perchennog ar hyn o bryd rhag iddo ddal yn dynach at y pris a nodwyd ganddo. LETTER : John P. Griffith to Mr. Owen concerning the proposed alterations to the house and chapel in Dublin.

3. 1893 Ebrill 10

COMMUNICION Pwyllgor Capel Dublin ymgymulliedig ym Menai Bridge.

4. 1893 Mai 17

LLYTHYR : John Owen, Welsh Church, Talbot Street, Dublin at Mr. Williams yn ei hysbysu fod amlinelliad o safle y capel a'r adeiladau cysylltiedig yn cael ei anfon gyda'r un post. Methodd a gweld yr un crybwylliad am waith y pwyllgor ac fe wna ymdrech i fod yn bresennol yn y nesaf.

5. 1893 June 6

LETTER : John Owen, Welsh Church, Talbot Street, Dublin to Mr. Williams informing him of the measurement of the ground belonging to the church. He hopes Mr. Fraser will be able to accompany Mr. Williams and that they will be successful. He is not very well these days and hopes to be at Andrew Villa, Criccieth next week.

6. 1893 Mehef 7

LLYTHYR : John Williams, Llangefni at Mr. Williams, Bangor yn dweud wrtho am ofala rhoi yr adroddiad yng nghofnodion y Cyfarfod Misol diwethaf. Nid oes angen trwydded i fynd i'r gymdeithasfa nesaf gan ei fod wedi ei benodi gan y pwyllgor i fod yn bresennol. Mae wedi anfon at yr ysgrifennydd i'w hysbysu y byddant yn disgwyl cael sylw y Gymdeithasfa at yr Achos yn Nulyn. Mae yn gofyn am ei gyfeiriad fel y gall y cyfeillion ym Mold ei ddisgwyl ef a M. Mewn pwyllgor a gyfarfu yno ar y 9fed gofynwyd iddo, os y ceir ateb mewn pryd oddiwrth berchemnogy tir yn Stryd Talbot, i erfyn ar Mr. Owen roi ei bresenoldeb yn y pwyllgor sydd i gyfarfod ym Mhorthaethwy ar Awst 21.

16. 1894 May 9 LETTER : J.F. Fuller, 179 Great Brunswick Street, Dublin to ? R. Lloyd, Holyhead. He is sending the tender and contract. The latter has to be signed by someone representing the trustees and who becomes responsible for payment of the money. His signature should be witnessed and it is not necessary to have all the names of the persons on the Committee. In his opinion the church will look shabby pebble dashed.
17. 1894 May 9 LETTER : Thomas Döckrell, Sons & Co., Merchants and Contractors, South Great George Street, Dublin to J.F. Fuller, 179 Great Brunswick Street, Dublin giving the amount of their tender for works at the Welsh Church. If they choose to have pebble dashing on the front and flank walls of the house and church there will be an extra charge of £27.10s. As their local plasterers are not accustomed to this type of work, they will have to get a man across from Wales to do it.
18. 1894 May 29 LETTER : D.M. Davies, 28, Brunswick Street, Dublin, to Rev. R. Lloyd, Kingsland, Holyhead informing him that it was agreed at a committee meeting last Sunday to ask the permission of the Rev. John Lewis, Talwrn to allow his name to be placed before the members of their church to take charge of their cause. He asks Mr. Lloyd to write to him at his earliest convenience regarding this.
19. 1894 Gorph 26 COPI CYLCHLYTHYR : R. Lloyd, Kingsland, Holyhead ynglyn a chasglu arian at adgyweirio Capel Dublin.
20. 1894 August 16 LETTER : R. Lloyd, Kingsland, Holyhead to J.F. Fuller, Architect, 179 Gt. Brunswick St., Dublin. Mr. Owen, Bryniau, Beaumaris went over with him to Dublin yesterday to see the progress of the work at the Welsh Church in Talbot Street. They were very much disappointed in the design of the pew ends which are not only antiquated and clumsy but highly inconvenient. He recommends certain cont./

alterations. They were also sorry to find that Mr. Fuller had neglected to incorporate their instructions with regard to wall and windows of the old house in the specifications. However they saw the contractor and have instructed him of their requirements. He adds that they were quite pleased with the general appearance of the place.

LETTER : J.F. Fuller, 179 Great Brunswick Street, Dublin to R. Lloyd Holyhead discussing the work to be carried out on the chapel in Talbot Street.

RHESTR : Enwau y rhai a roddasant 2s.6d. ac uchod at adgyweirio Capel Dublin. Capel Armenia, Caergybi.

23-24. 1894 Nov. 4

LETTER : J.F. Fuller, 179 Great Brunswick Street, Dublin to R. Lloyd, Holyhead enclosing Messrs. Dockrell's revised and final bill for works at the Welsh Church. He hopes the Committee will be satisfied with the result as he himself is very pleased, but unless the client feels the same way an architect is not happy. His fees will be 5 per cent on £799.14s.6d.

 LETTER : D.W. Davies, 28 Gt. Brunswick Street, Dublin to T. Forcer Evans, J.P., Holyhead enclosing bank draft, value £130.1s.11d., being the amount collected towards the reconstruction of the church. They feel they have done very well in their effort to collect and feel confident that the brethren in Anglesey will endorse their opinion.
29. 1895 Awst 27  
 LLYTHYR : R. Lloyd, Caergybi at y Parch. John Owen, Ysgrifennydd y Gymdeithasfa yn gofyn iddo alw sylw'r Gymdeithasfa at Sefyllfa anfoddfaol y casgliad at adgyweirio Capel Dublin. Mae y rhestr yn siarad drosti ei hun. Lymuna Mr. T. Forcer Evans, Caergybi roddi rhybudd y bydd yn cyflwyno trysoryddiaeth yr Achos hwn i Drysorydd y Gymdeithasfa yn Beaumaris.

 LETTER : W.C. Jones, (Hon. Treasurer) Lower Shop, St. Asaph to Mr. Forcer Evans, J.P. He has banked £13.2s.5d. at the North and South Wales Bank towards the chapel in Dublin. He apologises for such a small collection. The amount given from each church is listed.

 LLYTHYR : W. Roberts, Ynys, Abererch, Fwllheli at y Parch. R. Lloyd, Caergybi yn anfon siec a dderbyniodd oddiwrth Drysorydd Casgliad Dublin. Mae yn gofidio yn fawr na fuasai ychwaneg wedi dod i law, ond fe wnaeth ei orau ac fe anfonwyd cerdyn at bob eglwys.

 POST CARD : John Williams, Dwyran to Rev. Richard Lloyd, Beaumaris giving the amount received from Upper Mont. towards Dublin Chapel.

 LETTER : John Roberts, 7 Deva Terrace, Chester to Mr. Lloyd. He shall be pleased to meet Mr. Lloyd early next month. Although he did his best to push the Dublin Chapel collection, somehow it did not seem to take. He will explain when they meet. He gives a list of sums collected. In a post-script he adds that his expenses came to a full 20s. more than what he charged [He only charged 5s.]
