# SOUTHWARK DIOCESAN ARCHIVES Personal papers and special collections

#### TIERNEY-ROCK COLLECTION

208 numbered items. Nos 1-4 are early liturgical works; nos 15-41, 106, 118, 119, 172, 174 were described in HMC Third R, App, 1872, pp233-7. The location of the material reported lost in Catholic Archives, op cit, p16 has mostly been traced. Most of the remaining items not noted below are printed books and liturgical manuscripts. A MS catalogue by Canon Rory Fletcher c1930 is available in the diocesan archives.

TIERNEY, Mark Aloysius (1795-1862). First canon penitentiary of Southwark chapter 1852, historian.

ROCK, Daniel (1799-1871). Canon of Southwark Cathedral 1852, ecclesiologist, in charge of MA Tierney's papers after his death, bequeathed his own papers to the collection.

#### FLETCHER COLLECTION

FLETCHER, John George (Rory) (1861-1944). Rector of St Simon and St Jude, Streatham 1902-31, catalogued the MSS and early printed books at Bishop's House from 1919, canon of Southwark Cathedral 1927, historian. His collection consists of transcripts, notes, MSS, annotated and printed works on recusant history (c17 bound vols, 7 bundles, 10 printed books).

Additional MSS and some personal papers are also found in the Miscellanea series, as follows: MSS apparently extracted by him from diocesan records for autograph interest, incl letters to Thomas Grant from army chaplains in India at time of mutiny, from NPS Wiseman (2), from MA Tierney (3) from John Butt as chaplain at Scutari 1852 (1); copies of wills of James Dannell 1874, RA Coffin 1885; letters from JY Bramston to Robert Poynter 1800-15; letters to D Rock from NPS Wiseman and John Lingard; official war record of Thomas Grant's father, sergeant at Waterloo; MA Tierney 'List of papers returned to Ushaw' (Lingard correspondence) (1 box: J44).

### KNILL PAPERS

KNILL, Sir John 1st Bt (1824-98). Lord Mayor of London 1892-3, benefactor of Southwark Cathedral, and family.

Minutes of meetings of Committee for building St George's Cathedral 1847-1926, incl letters to Sir John Knill from AW Pugin c1845. Given by Lady Knill to PE Amigo 1934. Letters from Knill family to bishops of Southwark to 1942 added subsequently (1 box: J55).
