#### FOREWORD

When the Feoffees of the Common Lands of Rotherham were approached by the South Yorkshire Committee of the National Register of Archives, with a request that their records might be listed, they gave access to the first three boxes of older documents stored at their bank, and Miss M. H. Mackenzie, B.A., B.Litt., working as a volunteer, made a calendar, which was published in a small edition by the Rotherham Public Library in 1960, and a copy was lodged with the Register. In 1971, when this publication had become out of print, they allowed Miss M. Walton, B.A., F.L.A., the Archivist of the South Yorkshire Committee, to report on the rest of the records; and this revised list of all their documents is now issued both as a publication of the Rotherham Public Library and a Report to the National Register of Archives.

The documents listed by Miss Mackenzie are older and more important historically than those listed by Miss Walton, whose report contains less detail and no verbatim transcripts such as those which add interest to Miss Mackenzie's work, as they would present little difficulty to any enquirer who might seek permission to consult them. Miss Mackenzie has also classified her entries by content and a key to the numbering of the documents in each box is appended.

Miss Mackenzie's original preface is reprinted, with little alteration, below:

"I wish to express my sincere thanks to the Feoffees of the Common Lands of Rotherham, and especially to Mr. F. Ogley, Clerk to the Feoffees, for allowing me to examine the first three boxes of their papers. This private collection of papers is notable, for it reveals the emergence and development of a society which continues its beneficent work in Rotherham at the present day. Mr. F. Ogley has spared the time to read through and discuss with me the material I have collected. I owe a very deep debt of gratitude to the late Mr. F. J. Boardman, who asked me to undertake this work and gave me every facility for research in the Rotherham Central Library. I have received the same kindness and consideration from his successor, Mr. L. G. Lovell, from the staff of the Reference Library, and especially from Miss J. R. Bugler, who has assisted me greatly by her interest, her wise advice on the presentation of this report and by undertaking the checking and duplication of the stencils. My thanks are also due to Professor G. R. Potter for his encouragement and advice, and to Mrs. J. Martin, Mr. W. R. Serjeant and Miss R. Meredith for their valuable help in reading and transcribing some of the documents.

Variation of emphasis on material has been necessary, and I have tried to develop the following subjects - the constitution of the Feoffees; interrogatories taken at Rotherham in connection with certain law suits; the locations and boundaries of the properties; references to chantry lands, whether concealed, in the hands of the Crown or in the hands of the Crown's patentees; examples of local custom; relations between the Feoffees and the leading families of the district; bequests left to the Feoffees; the development of Rotherham after the enclosure of the open fields in 1764; the growing importance of mineral rights in leases.

Two points in the reading of this calendar need explanation. I found that the papers had been arranged, partly on a chronological basis and partly in bundles on a subject basis. I have followed the subject basis in Box II, as the constitution and the elections of the Feoffees are best studied apart from the other documents. I have not altered the position of any document in Boxes I and III, but, in accordance with the requirements of the National Register of Archives, I have listed these papers under the appropriate heading in chronological sequence: thus III/2/26/ indicates that this lease is No. 26 in bundle 2 in Box III. Where the parish of the parties is not mentioned, it should be assumed that they lived in Rotherham.

With regard to place-names, I have followed the spelling in the deed and, where this form is difficult to recognise, put the modern spelling in brackets. A comparison of the different spellings of Masbrough or Bridgegate over a period of three hundred years shows the instability of place-names and helps us to realise the case that must be taken in identification with modern sites.

# ADMINISTRATIVE RECORDS IN THE FEOFFEES' OFFICE

Minutes of meetings of the Feoffees of the Common Lands of Rotherham.

The deed box in the Feoffees' Board Room contains a quantity of legal documents, most of which are drafts of leases already listed as being at the bank, or agreements, etc. connected with the lease, all tied in marked bundles. The following are original deeds, or deal with transactions not included in the deeds at the bank:-

Lease to the Hallamshire Coffee House Company Ltd., of 20 Westgate; rent £95. 1925.

None of the schemes suggested had come to fruition, partly because of the death of an intending donor, and the inability of the Feoffees to accept the conditions of another. 1901-1915.

"The said lands ... shalbe used and ymployed to diverse good uses as before tyme hath bene accostomed (that is to say) for the relief of the pore people of the said Towne for the manteyning and repayring of Bridges in and about the said towne and for and towardes the discharge and contribucion of Fyftenes taxes musters and other comon charges wherewith the said towne of Rotherham and inhabitantes therof may be charged and in ease and Releife of the pore people of the said towne of Rotherham". Feoffees must be resident in the Township of Rotherham; they cannot hold or speculate in the common lands; when reduced to six in number a new election must be held; two Feoffees, chosen each year by lot, must serve as Common Greaves to collect the rents and make a statement of accounts on Lammas Day in the Parish Church. The common lands are to be leased in periods of twenty one years and for rents not lower than those obtaining in 1589.

- 2) The other half is left for a yearly obit for the repose of the soul of the donor, his parents and friends. Detailed instructions are laid down for the payments and charities connected with this service.

This copy was obtained from York in 1606, when the Deputy Auditor for Yorkshire was disputing the Feoffees' claim to the Denaby lands. It is signed - Nic Mountney, F. West, Francis Dickenson.

Nicholas Mounteney and Francis Dickenson, "upon speciale trust and confidence in them reposed by the said Robert Okes", are named as Feoffees in trust for the administration of property in Little Dalton, the proceeds of which Robert Okes' widow is to enjoy during her lifetime. On her death the legacy is to pass "to the use of the schoolmaister of the grammer schoole of Rotherham ... Provided always that yf yt shall happen ... that such schoolmaister as shall be there placed be negligent carelesse or ydle in his place ... that then the said Nicholas and Francis ... ymploy convert and bestowe the rentes and profittes arising of the said moytie ... to the releif and succor of the poorest and most aged and impotent sort of the inhabitants of the said towne of Rotherham".

Nicholas Mountney and Francis Dickenson are named as Feoffees in trust for a legacy to provide an usher for the Grammar School and a preacher. This legacy is contingent upon the deaths, without heirs, of Thomas Colte's daughter and niece. 16 November, 1635, Francis West and Antony Rogers are the Feoffees in trust. In Feoffees' Book I, p. 127, there is a reference to £40 given by Thomas Colte for the poor of Rotherham.

27 December, 1625 (?) Extracts from the Will of John Shawe of Rotherham, yeoman. I/25/a/

The rents of three messuages in Rotherham (amounting in all to 90/- p.a.) are left to the Vicar, Churchwardens and Overseers of the Poor of the Parish of Rotherham to "dispose the same for the releefe of the blind lame and other most needfull poore". The rents of two tenements in Sheffield are left to the Vicar, Churchwardens and Overseers of the Poor of the Parish of Ecclesfield for the same purpose. Legacies (secured on property in Rotherham, Greasbrooke lane, Rawmarche lane, the Tenter meadow and Wincobanke) are left to his wife and relations. The Feoffees are not mentioned, but from a list of 26 December, 1630, it is clear that Francis West had sold some of these properties to John Shawe.

Conveyance (lease and release). William Ridgeway of Masbrough in the parish of Rotherham, butcher, to John Crumack. An allotment on Rotherham Common made to George Newton, for £109. 26 and 27 January, 1809.

Mortgage. Crumack to William Whitehead of Laughton-en-le-Morthen, farmer. The two allotments, for £200. 31 December, 1814.

Conveyance. The Earl of Effingham to Thomas Wright of Masbrough, merchant. The tythes of a parcel of ground in Great Bradmarsh in Brinsworth in the parish of Rotherham, for £14, as redemption fee. 18 March, 1812.

Copy of the will of John Crumack (trustees are to sell his lands). 1816.

Conveyance (lease and release). Robert Thompson (surviving devises in trust of John Crumack, with the consent of William Whitehead the mortgages), to William Craven of Rotherham, auctioneer. The two allotments on Rotherham Common or Moor, for £217.1.0. to Whitehead, and £26.1.0. to the trustee. 20 and 21 February, 1818.

Conveyance (lease and release). Thomas Wright of Masbrough to William Craven of Rotherham, gentleman. The land in Bradmarsh, for £156, with a clause for the merging of a term. 9 and 10 March, 1818.

Conveyance. William Craven of Rotherham, auctioneer, to the Feoffees, represented by the Earl of Effingham and Samuel Walker of Aldwarke Hall in the parish of Ecclesfield. The two Rotherham Moor allotments and an allotment of Thomas Wright's in Bradmarsh for £40 and a croft at Westgate End in Rotherham. 4 and 5 November, 1822.

Conveyance (lease and release). Samuel Jenkinson of Hooton Roberts, farmer, to the Feoffees. A messuage in Jesus Gate adjoining the west end of the Banke House, for £90. 17 and 18 June, 1828.

Order by the Feoffees to agree with the Earl of Effingham to
purchase the tithes, tithe rents and chief rents of the Common
Lands, with £200 bequeathed by Edward Bellamy. 7 March, 1779.

Minutes of a meeting of the Feoffees, Churchwardens, and principal inhabitants at which it was agreed to charge the Common Lands with £80 a year for distribution to the poor, on accepting £200 from the will of Edward Bellamy. 6 April, 1779.

The tithe rents of several closes in Rotherham which were allotted to the Feoffees by the Commissioners of the enclosure of Rotherham moors and commons, which rents (£6.8.8.) were granted to the Earl by the Commissioners; and a fee farm rent (£1.4.5.) payable on the Common Lands of the Feoffees, for £200, the rents to be used solely for the relief of poor persons in accordance with the provisions of Edward Bellamy's will: reciting a deed providing a jointure for the Countess of Effingham to be taken into account. 10 August, 1779.

York), and the Upper Royd, the Nether Royd, the Back Croft, the Far Croft and the Upper Field, for £200.

Agreement. The Feoffees agree to sell to the Corporation of Rotherham two fields (formerly six fields) once part of Rotherham Common, bounded in part by Canklow Road, Rotherham Cemetery and Boston Park, for £215. 10 January, 1931. Plan.

Conveyance (lease and release). Mary Jaques of Beverley (co. York), spinster, only child and heir by John Jaques, late of Doncaster, wine merchant deceased, by Mary his wife, also deceased, daughter of Mary Hallowell of Doncaster, widow, to James Wilkinson of Rotherham, surgeon and apothecary. Two messuages at the east end of Westgate in Rotherham, formerly in one house and called The Ship, for £372. 10 and 11 November, 1777.

Mortgage. James Wilkinson to Richard Ducker of Abdy in the parish of Wath upon Derne (co. York), yeoman. The same, for £200. 12 November, 1777.

Mortgage. James Wilkinson to James Crawshaw of Masbrough in the parish of Rotherham, ironfounder, for £250. The same. 14 June, 1791.

Conveyance and assignment (lease and release). James Wilkinson to John Hurst of Clough in the parish of Rotherham, esquire, Edward Prest of the City of York, druggist, and Joshua Hepworth of South Bramwith (co. York), gentleman, creditors and trustees for other creditors, in trust to sell for the payment of the creditors; and he assigns to them debts, stock in trade, etc. 18 and 19 May, 1798. Signed as exhibited in his bankruptcy case at Barnsley.

Bargain and sale. Watson Scatcherd and Jonas Clark, esquires, and John Hawke, gentleman, commissioners in James Wilkinson's bankruptcy, to Joshua Hepworth of South Bramwith and Thomas Carnelly of Rotherham, innholder. A messuage at the east end of West gate which has been erected in place of two messuages pulled down, a garden at the upper end of Talbot Lane and an allotment of Common, and any other estate he may have, to use in an endeavour to raise money for the payment of Wilkinson's debts. 4 August, 1798.

Assignment of mortgage. Richard Ducker to the assignees, being parties to await the inheritance. 21 January, 1799; and Surrender of term. John Crawshaw to the assignees, for £250. 5 June, 1799.

Conveyance (lease and release). Hurst and Prest, and the assignees in bankruptcy, to William Wildsmith of Rotherham, surgeon and apothecary. The property, for £525 and the remainder of the mortgage term. 3 and 4 June, 1799.

Conveyance (lease and release). The executors of William Wildsmith, deceased (William Yates and George Hurst), and Hepzibah his widow, to John Binks of Rotherham, plumber and glazier, and Francis Smith of Rotherham, plumber and glazier. The property (now again described as two messuages), for £770, with trusts. 26 and 27 May, 1812.

Mortgage. Binks and Smith to Yates and Hurst, for £600. 28 May, 1812.

Assignment of mortgage. Yates and Hurst to John Glossop of Harthill (co. Yorks) malster, for the £500 still owing. 7 April, 1820.

Conveyance. William Cross of Rotherham, victualler (with the consent of Earl Fitzwilliam), to John Binks and Francis Smith. A messuage in Westgate (adjoining their premises bought in 1812), for £70, paid to Earl Fitzwilliam, paying off a mortgage. 2 and 3 April, 1820.

Conveyance (lease and release). John Smith of Doncaster, yeoman, and Robert Smith of the same, cordwainer, administrators of the goods, etc. of Francis Smith, deceased intestate, their brother, to John Binks of Rotherham, plumber and glazier. Francis Smith's moiety of the premises in Westgate - two messuages and the site of a third which has been pulled down and a gateway built on it - and of their joint business, for £250. 7 and 8 July, 1823. Dwelling on Rotherham Bridge with stable and swine hulls. Rawmarsh Lane. Dwelling in Westgate. Lands and meadow in Rotherham, Bradmarshe and Marsburghe. Cottage in Wellgate. House in Milnegate. Sawell Closes in Dalton. Dwellings in Marsburghe. "A brode land in the Ealand".

The earliest gives only tenants and not locations, and there are a few unlocalised entries even in the latest one. For 1599 - 1606 there are entries for lands in Denaby.

### Separate skins:

Herbage and winter pasture "to the town's use for land kept enclosed" in Doncaster Gate, Snell Croft, the Crofts, Colledge Leys, Canklowe More; Thomas Clayton's dues near the Don are listed in some detail. Lists of arrears of rent in most years.

Both series run from 1599 to 1633. For succeeding rentals, see p. 51.

Appointment. "The Feoffees of the Common Lands of Rotherham and a great number of other inhabitants" appoint Henry Saxton to be the schoolmaster, with the use of the tenement called the Schoolehouse: for a stipend (the King's?) of £10 with the addition of £7.13.4. to be contributed by the citizens (some of whom sign the agreement). Undated. Nicholas Mountney and Francis West are the Greaves.
