380GRL GARSTON LAND CO LTD, 1862-1976

According to notes on the Company in 3/7 below, part of an estate in Garston was acquired for speculative development in 18o2; in 1865 this was conveyed to Arthur Sinclair who formed the Land Company in 1865. The Company continued to acquire land in the docks area of Garston (see schedule of deed in 3/7) — this was subsequently sold off, but the Company retained perpetual interest in the railway sidings which had been provided to service the land.

From 1953 the Company was a wholly-owned subsidiary of Garston Bottle Works Ltd, before going into liquidation in 1963, at which point all its remaining assets were transferred to the holding company.

Corporate records, including annual reports are rare survivals, no doubt due to the bombing of the Company's registered premises in July 1941 (correspondence notes that papers and records relating to the Company were destroyed: see 1/2 below.) The majority of records deposited comprised routine correspondence relating to share dividends, tax matters etc; much of this has been destroyed, and the remaining correspondence, dealing with land purchased, weeded.
