Administrative history

Ind Coope Tetley Ansell Ltd was registered as a limited liability company in 1961 to merge the groups of Ind Coope Ltd, Tetley Walker Ltd. and Ansells Brewery Ltd. The company changed its name to Allied Breweries Ltd in 1963. By 1977 the Allied Group owned 7,650 licensed houses, 1,250 licensed shops and 42 hotels.

The company acquired J Lyons & Co Ltd (est. 1894), international food manufacturers and distributors in 1981, and Allied-Lyons plc became the parent company of the new group. In 1986 Allied Breweries owned over 7,000 licensed houses, over 20 main trading companies, 6 breweries, and 30 United Kingdom distribution centres.

In 1994 Allied Lyons merged with Pedro Domecq, the leading spirits company in Spain and Mexico and began trading as Allied Domecq PLC. Allied Domecq PLC decided in 1999 to concentrate on the world-wide spirits market. It sold its UK retailing interests to Punch Group Ltd, comprising 3,500 pubs.

Custodial history

The material comes from the strong room of what was Allied Breweries' major brewery in 107 Station Street, Burton-on-Trent. When the Punch Group Ltd bought the retailing interests of Allied Domecq PLC it also inherited its records. The Punch Group decided it had no use for the records and in order to preserve them the Brewery History Society arranged for their distribution around record offices, museums and other archives. These records were deposited by Dr. Richards on behalf of the Brewery History Society and the Punch Group Ltd in November 2002.

1921-1970

Peter Walker (Warrington) & Robert Cain & Sons Ltd was registered in September 1921 as a limited liability company to acquire and amalgamate Robert Cain & Sons Ltd, Mersey Brewery, Stanhope Street, Toxteth, and Peter Walker & Sons (Warrington & Burton) Ltd, Dallam Lane Brewery, Dallam Lane, Warrington. The company took over Robert Blezard & Co, Liver Brewery, Scotland Road, Liverpool in 1921 and William Tong & Sons Ltd, Diamond Brewery, Deane Road, Bolton, in 1923.

The Mersey Brewery was sold to Higson's Brewery Ltd in 1923 and brewing was concentrated at Warrington. The company's name changed to Walker Cain Ltd in 1946 and it merged with Joshua Tetley & Son Ltd, Leeds, in 1960, through a holding company, Tetley Walker Ltd.

Records relating to licensed premises in Merseyside owned by Ind Coope Ltd.

Edward Ind, son of James Ind, brewer in Baldock, Hertfordshire, purchased the Star Inn, High Street, Romford, Essex, from George Cardon in 1799. He built a brewhouse on the site and in 1845 went into partnership with the brother Octavius and George Coope. In 1848 Edward Vipan Ind joined the partnership which was known as Ind Coope & Co from 1856. During that year the firm opened a second brewery in Station Street, Burton-on-Trent, Staffordshire. It became a registered company in November 1886 and proceeded to acquire several brewery companies across England.

The company went into receivership in January 1909. Certain assets were acquired from October 1910 by Ind Coope & Co (1912) Ltd, registered in 1912, from the receivers for various debenture holders. Ind Coope & Co Ltd was struck off the register of companies in 1922 and Ind Coope & Co (1912) Ltd changed its name to Ind Coope & Co Ltd during the following year.

In 1934 the company acquired Samuel Allsopp & Sons Ltd, High Street, Burton-on-Trent, in 1934 and it changed its name to Ind Coope & Allsopp Ltd. In 1959 the company changed its name to Ind Coope Ltd and in 1961 it merged with Tetley Walker Ltd and Ansells Brewery Ltd to form Ind Coope Tetley Ansell Ltd (later Allied Breweries Ltd).

Prior to this merge in 1960 Ind Coope Ltd appears to have sold the licensed premises it owned in Liverpool to Ind Coope (North West) Ltd, 8 Cumberland Street, Manchester. (see M380 ALL/3/3).

The business was founded in Tynemouth Street, Liverpool, in 1871 by John Houlding who ran the brewery until his death in 1902. William Houlding then took over the business and ran it until his death in 1906, after which it was operated by his executors.

Houlding's Brewery Co Ltd was registered in 1914 as a limited liability company to acquire the business. The company, along with 21 licensed houses, was taken over by Ind Coope & Allsopp Ltd, Burton-on-Trent, Staffordshire, in 1939 and ceased to brew.

Pension records. The records do not contain any names or details of personnel.

The Garston Bottle Co Ltd was formed in 1915 and established its factory on the north bank of the Mersey, just to the south of Garston Docks. Its original production was confined to green glass, but it closed in 1922. It was restarted in 1933 with Mr. F. J. Shepherd.

In 1959 after a close association during the preceding 25 years during which C. Squires and Sons Ltd had acted as selling agents for Garston in the South the two Companies agreed to join forces to facilitate coordination and development of sales.

In 1963 the company went into liquidation and it appears to have been bought by Ind Coope Co Ltd.

The records of the Garston Land Co Ltd, 1862-1976, which was a subsidiary of Garston Bottle Works Co Ltd from 1953-1963 are listed at M380 GRL.
