their consent and to carry out the business of the foundation, they contain the appointment of the above-mentioned commissaries.

Then William Lynde produced the King's letters patent for the foundation of the college, sealed with the Great Seal, to which, after they had been read aloud by the notary, the commissaries gave their consent and authority. The foundation charter is then recited.

Then master Henry Sever, the Provost, and the priests, fellows, clerks, poor scholars and one inform and poor man, John Burdon, named in the said charter, appeared before them and the commissaries erected the parish church into a collegiate church and decreed that it should be known as the collegiate church of the Blessed Mary of Eton.

On 20 October the church was appropriated to the Provost, Fellows and College. Before the commissaries sitting as a tribunal, William Lynde personally appeared and exhibited a certificate of citation made by William Haston, chaplain mandatory, on the instruction of the commissaries. document, dated 13 October, is recited. It instructed him to summon the archdeacon and the incumbent and other interested parties to appear in the church on 20 October. Accordingly on 15 October, during the solemnization of mass, they had been summoned. Only the archdeacon and the incumbent appeared. All other parties were declared contumacious and precluded from objection to the appropriation. then, as archdeacon of Buckingham, gave his consent to the appropriation and John Kette, rector and incumbent of the church, of his own free will resigned. His resignation is recited. The commissaries accepted the same and the archdeacon then inducted the Provost.

The persons and places named in it, however, have been indexed.

The defendants say the places consist of two closes called Estbalons containing 30 acres of pasture and 10 acres of woodland, and Westbalons containing 10 acres of pasture, and that a certain Richard Restwold, esquire, and William Mereys, clerk, before the said supposed entry were seized of the premises in fee and gave the same to Robert Manfeld in fee tail with remainder to John Manfeld, William Manfeld, Richard Manfeld and the right heirs of Robert Manfeld. The plaintiffs claim they were leased the premises for life by Restwold and Moreys, but this was long before the grant to Manfeld, who accordingly entered the same.

The plaintiffs say that long before Restwold and Moreys had any interest in the premises, Robert Foughley was seized thereof in fee and enfeoffed William Weynflete, bishop of Winchester, and William Westbury, provost of Eton, and Edmund Brudenell, with the same; who were disseised unjustly and without judgement of the same by Restwold and Moreys. Later Brudenell died. The grant as aforesaid was made to Manfeld. The bishop and provost re-entered and expelled Manfeld. They granted the same to the plaintiffs.

Finally on 3 November 1480 judgement that Restwold and Moreys unjustly and without judgement disselsed the bishop, the provost and Brudenell. Damages assessed at 26s:8d

Introduction

By the royal endowment of 25 March 1441 the College of Eton was granted a farm and rent of 51:14s:2d which Walter Striklond, esquire, paid the crown for the custody of all lands, tenements, rents and services, with their appurtenances, in North Mundham and Compton, co. Sussex, and "Welegh" or Wheely, in Warnford, co. Hants, which had formerly belonged to the abbey of Lucerne in Normandy. Striklond held the foregoing on a seven year lease from Michaelmas The College was at the same time granted the reversion of the lands. They were among the College properties resumed by Edward IV, who granted them on 26 February 1462 for 20 years to William Beaufitz1. They were however re-granted to the College on 17 July 14672. only to be lost again by a grant to the Dean and Canons of St. George's Windsor on 17 May 14740. At what exact date the College recovered the property does not appear either

In none of the foregoing grants were the premises described as the manor of Fishers and Brimfast, their designation in the court rolls and College leases.

from the Patent Rolls or the records at Eton.

These shiftings in the early days of the College tenure will sufficiently account for the poverty of early records at Eton concerning this manor, there being none for the period before the College ownership. Two of the College court rolls, however, survive of the time before Edward IV's resumption of the lands.

Introduction

By the royal endowment of 25 March 1441 the College of Eton was granted a farm and rent of 51:14s:2d which Walter Striklond, esquire, paid the crown for the custody of all lands, tenements, rents and services, with their appurtenances, in North Mundham and Compton, co. Sussex, and "Welegh" or Wheely, in Warnford, co. Hants, which had formerly belonged to the abbey of Lucerne in Normandy. Striklond held the foregoing on a seven year lease from Michaelmas 1439. The College was at the same time granted the reversion of the lands. They were among the College properties resumed by Edward IV, who granted them on 26 February 1462 for 20 years to William Beaufitz1. They were however re-granted to the College on 17 July 14672., only to be lost again by a grant to the Dean and Canons of St. George's Windsor on 17 May 14743. At what exact date the College recovered the property does not appear either from the Patent Rolls or the records at Eton.

In none of the foregoing grants were the premises described as the manor of Fishers and Brimfast, their designation in the court rolls amd College leases.

These shiftings in the early days of the College tenure will sufficiently account for the poverty of early records at Eton concerning this manor, there being none for the period before the College ownership. Two of the College court rolls, however, survive of the time before Edward IV's resumption of the lands.

Introduction

on 1 March 1443, Humphrey, duke of Gloucester, received a licence to grant to the Provost and College of Eton interalia a rent of 81:65:8d from the issues of all manors and lands in the county of Wiltshire which had belonged to the alien deanery of Mortain, in the diocese of Avranches, Manche, Normandy¹. This property included the manor of Hanging Langford in Steeple Langford. On 2 April 1443, the duke made his grant². In Edward IV's patent of 17 July 1467, the lands are described as the manor or priory of Hanginglang-ford.³.

No documents relating to the manor from before the period of the College ownership survive at Eton, but the Provost was holding a court at Hanging Langford only three days after the date of duke Humphrey's conveyance. The first court roll of the College, of 5 April 1443 (44), contains a list of the customary tenants, with a record of their fealty. In some of the early rolls (47, 51) there is a list of those villeins who paid capitagium or head tax of 8d each. It is presumed that this represents some commutation of services. In 1566 (65) a tenant produces in court letters of manumission granted by the College in 1537, to his father and that father's sons and daughters.

Thomas Valence, of Eton, gent., who had a reversionary lease of the manor on 12 August 1559, has been conjecturally identified here with the headmaster of that name, who, again, according to Wasey Sterry, was probably identical with the Thomas Valence M.A. of Oxford, who was presented by the College to the living of Sturminster Marshall in 1565.

Incidentally the Richard Watkins alias ap Valence, to whom Sterry refers 4°, can be further substantiated from the State Papers Domestic where, under the date 1563, there is a list

of

of scholars of Christchurch driven away at the beginning of queen Mary's reign, which includes Mr. Watkyns who is described "schoolmaster of Eton".

Francis Parkins or Perkins, of Steeple Langford (69, 70), was a recusant. Richard Tredway, of Beaconsfield, esq., who took a lease of the manor in 1598 (6), has often been met with in the Eton records, acting as the College steward on various manors. In Eton College Records vol.36 there is a good deal about him and his family, including his will. His granddaughter Lettice, mentioned therein, is to be found in the Dictionary of National Biography. She founded a convent for English girls in Paris in 1634 and was abbess of the same.

The meaning of the word Rowles or Rowlesse in the expression "a half virgate Rowles called Compton" (115, 118), has not been established.

The fellowing numbers were formerly part of the file, no.83, and have been detached - 112-123, 147-152.

References to Hanging Langford can be found here and there in other volumes of Eton College Records, particularly in the Piddlehinton volume, as the steward for Piddlehinton, Hanging Langford and Charlton Parva was frequently the same person and would at times make up a single roll for the three properties.
