These documents were stored in a large wooden box, probably 18th century, but it has not been possible to identify it with any of Tom Martin's references to 'useless old deeds'. Many predate the foundation but while some refer to properties later lost (eg Deerhurst Priory) others relate to properties the College continued to own, such as Stogursey, or to places whose connection with Eton is unexplained. There was no archival arrangement apparent so arrangement by place seemed most likely to assist searchers, with cross referencing as necessary. A few items such as a will and a mandate have been grouped at the end.

It is not clear why this document came to Eton. However, in 1462 the College received a grant of the priory of Ellingham, Hampshire, which also belonged to St. Sauveur, so the document may have been transferred in error with the Ellingham ones. The College also acquired Yenston, Somerset, which belonged to another house in Coutances, the Abbey of St. Sever (See Friends Newsletter September 2003)

This appears to be a draft or perhaps simply a note of points agreed; it is not dated or sealed and the parties have not signed although the text specifically mentions that they have done so. The next items are the formal agreements covering the two disputes and receipts for payments.

### ECR 49/314 Resumed estates: miscellaneous deeds

This group of deeds was stored in a wooden box (19cm x 11.5cm) with a sliding lid on which was marked in ink Beck/Abby/Okeburn/L-Q. The hand is probably 18th century but the box may be earlier. Tom Marten's Digest (1724) refers to several boxes of deeds, many of which were broken up later. The most likely candidate for this box is p.4 (drawer 4, item 8, Cottisford and Fringford): 'old deeds in a small box, belonging to Beck Abbey' or perhaps p.17 (drawer 24): 'Several old grants etc. to the Abbeys of Becco, Font-Ebrard, Sigineto, Shirebourn, Cowick, Derherst etc. and some other deeds & rentals etc either unknown or of little use'.

The Prior of Okeburn or Ogbourne was the title given to the procurator or agent of the Abbey of Bec in all its business in England and Wales and the appointment of one such procurator in 1331 is included. The majority of the documents do indeed refer to lands originally belonging to the Abbey of Bec but properties of the Abbeys of Fontevrault and St. Vigor (Cerisy le Foret) are also included. All, however, relate to properties resumed by the Crown and not regranted to the College and with the exception of a group relating to Monk Sherborne in Hampshire they all date to the period before the College's ownership.

Introduction

The records catalogued in this volume relate to miscellaneous estates of the College, being mostly found detached from the main body of records of the estates to which they belong. In the title page to each section, the reference to a catalogue volume of the Eton College Records directs the reader, where possible, to the volume in which the acquisition of the property by the College is recorded. The presence of certain documents among the records of the College, such, for example, as those relating to Market Overton and Tolpuddle, is unexplained.

This 'Addenda' volume has gathered in some ancient deeds, notably those relating to the Sherbornes in Hampshire (263 - 266) and to Stogursey (200 - 271). It has also some interesting documents of the early years of the College. A survey of the alien priory lands granted to the College, made in the autumn of 1441 (294), shows exactly what revenues at that date the College had enjoyed from these estates. Another document (296) lists, in the middle 1460's, at the nadir of the College's fortunes, the properties contained in Henry VI's first charter of endowment that were no longer in the possession of the College. The chaplain's account of 1446 (170) is a reminder of how very far the founding of the College was from transforming the church of Eton overnight into a college chapel. The documents concerning the provision of building stone from Yorkshire (172 and 173) suggest that the journey by sea was a hazardous one.

When the College lost the Hospital of St. James, it lost among other things a house in London. It has been noted that in its leases of the Ball in Holborn, this loss was to some extent compensated by the provision there of "a sufficient chamber or lodging with bedding and other furniture meet for lodging for the Provost, Vice Provost and Fellows as often as they or any of them shall come to the city of London about the College business". (See E.C.R. vol. XVI p. 55 no. 3). A lease of Copped Hall in the Crane of the Vintry of 1540 (248) reveals that a

similar provision there obliged the lessee to supply
"an honest chamber" for the lessors and their servants
whenever they should come upon the College business.

An interesting series of documents (85 - 109) of the period 1840 to 1842 relates to an exchange with the Crown of the Christopher Inn and its adjoining premises in Eton for part of the College estate at Frimrose Hill. The memorial from the College to the Commissioners of Woods and Forests, proposing the exchange, contains the following passage (86):

"It is highly desirable for the good discipline health and recreation of the youth educated at the said College that the buildings and land in its immediate vicinity should be under the control of your Memorialists so as to preclude the risk of additional buildings being erected or trades or businesses carried on there which might by the noise and traffic attending the conducts of them prove of annoyance to the College by disturbing attention and interfering with the orderly rules and regulations of the Establishment".

This high purpose was at length achieved (not without delays and mutual recriminations on the part of the surveyors and solicitors concerned) and embodied in an Act of Parliament (109).

The Hampstead property of the College is rich in documents, many of which have been examined by Sir John Summerson in his study of the growth of this London suburb. They illustrate, among other things, the problems faced by landowners with the coming of the railways. On another subject upon which no Eton estate records are silent, namely upon the size of the fine for renewal of a lease demanded by the College, and generally contested by the lessee, the Hampstead correspondence supplies us with a general statement by a College bursar of the principles on which the College made its calculations (57). "The grand general principle of all calculations for Fines

upon the renewal of purchase of Beneficial Leases is this, of that the purchaser shall be enabled to repay himself, at the expiration of the term granted, the original purchase money with five per cent interest thereupon". Calculations as seen from the point of view of the clerical lesser rather than his lessee are illustrated in no. 254.

The Hullavington leases of 4 November 1593 (233) and 30 July 1605 (235) are unusual in being leases for life. The normal practice of the College was to lease for a term of years. The former of these leases shows the coming into operation of the Statute of 18 Elizabeth c.6., by which one third at least of the rent was to be reserved in corn on leases of lands of Colleges in the Universities or of Winchester or Eton, to which any tythes, arable land, meadow or pasture appurtained.

The ordinance contains an inspeximus of letters dated on the feast of St. Martin 1251, of Vincent, the prior, and the monks of Stokescurcy, to whom the advowson of that church belongs, submitting to such ordinance; and an inspeximus of letters, dated April 1252, of R., the abbot, and the convent of St. Mary of Lonleium, to which the priory of Stokescurcy belongs, in which the abbot, after reciting an inspeximus by R., abbot of Lonleium, of the said letters of Vincent, promises to observe the said ordinance. The ordinance appropriates the church of Lullingstokes to the monks of Stokescurcy, to be converted to their own uses. They are to see that the church is served by a suitable chaplain and a clerk, and to maintain the chancel and the books vestments and other ornaments. The bishop has considered the intelerable and grave deficiency which the monks are forced to undergo from the thinness of the substance assigned to their house and the commodity, utility and remedy they would derive from the church of Lullingstokes which is so near that it almost seems united to the parish of Stokescurey. And it has been his purpose to prevent all matter of contention which might easily arise between the monks and the rectors of the church by reason of the tythes of the demesne of the said vill which the monks receive as a great part of their sustenance.
