Foreword

Most of the College property in London and the suburbs, of which the records are catalogued in the present volume, formerly belonged to the Hospital of St. James, which was granted to the Provost and College by Letters Patent of 30 October 1449. But the College held the Hospital for less than a century and few records survive which relate to the actual Hospital itself and the land in its immediate vicinity. In 1631 the Provost was compelled - for he can hardly have been willing - to exchange the Hospital and all but some of its remoter appurtenances with the Crown (see Hospital of St. James no. 10 p. 7 ). The present volume is concerned almost entirely with such property of the Hospital in London and the suburbs as the College was then allowed to keep. The tenements in the Vintry were, however, never part of the possessions of the Hospital and came to the College by a grant of 1446, while the house and four shops in the parish of St. Botolph's Aldersgate appear in the original Letters Patent of endowment of 1441.

Westminster (1 - 41)

The College tenements in Westminster were situated at the southern end of King Street and these records describe in some detail both the situated and the actual, or projected, buildings at various periods.

A survey of the site (no. 35), apparently made by the architect Henry Keene, describes it as follows:-

First in a line beginning at the South East End of Bow Street otherwise Theiving Lane in the Parish of Saint Margaret in the City of Westminster and going northward along the west side of King Street to the South East Angle of Brown Alley & then going westward to the south west Angle of the said Alley including the whole thereof from thence proceeding northward along the west side of the Party Wall dividing the Freehold Estate of John Wiseman Esquire from certain other Premises belonging to the Provost and Fellows of Eaton College & Humfreys Ram now in the tenure of Joseph Waring to Gardiner's Lane and then proceeding westward along the south side of the said Lane to the north west corner thereof next to Duke Street then proceeding southward along the east side of Duke Street and the east and south east sides of Delahaye Street as far as the party wall dividing two Houses situate at the north end of Long Ditch one whereof is now in the occupation of Richard Turner Apothecary and the other in the occupation of John Snow Bricklayer not taking in the said House now occupied by the st John Snow or any part thereof then proceeding eastward one hundred and forty Feet along the north side of the wall which parts the garden of the st Richard Turner from the yard and garden of the said John Snow and from thence returning southward Fifty Feet to a Break dividing the ground of Duval from other Land in the Tenure or occupation of Henry Cheere Esq? and then going from the said Break eastward One hundred Feet to the west side of Rose Alley situate on the north side of

Bow Street otherwise Theiving Lane aforesaid then beginning at the south west Angle of Rose Alley aforesaid and going Eastward along the north side of Bow Street otherwise Theiving Lane aforesaid as far as the south east Angle thereof next King Street 2<sup>dly</sup> Beginning at the South East Corner of Princes Court in the Parish of St. Margaret Westminster and going northward along the East side of Saint James's Park Wall 140 feet in length then going Eastward to Delahaye Street along the south side of the party wall of the House now in the Tenure of Streach Esq. but not including the same then going southward along the west side of Delahaye Street as far as and unto the south east Corner of Princes Court aforesaid.

I have dated this document ca. 1769, the date that

Keene appears to have been employed by the College. But

it may be somewhat earlier, for "Henry Cheere, esquire",

is presumably identical with the sculptor of that name, a

famous Westminster figure, who was knighted in 1760 (D.N.B.).

An interesting document dated 1638, which appears only to relate to contiguous property, belonging to the Dean & Chapter of Westminster, is no. 5. It concerns Moses Pitt, bookseller, the publisher of the 'English Atlas'. "The 'English Atlas'", says the D.N.B. "was not successful from a pecuniary point, and Pitt also had losses in building speculations". Our document bears out the latter statement. Unfortunately it has been mutilated, but there seems no doubt that it is a mortgage of some of Pitt's Westminster property, which was already heavily mortgaged. It is conceivable that its presence here is accounted for by the College connection with Henry Keene, for Keene was surveyor also to the Dean and Chapter of Westminster.

White Beare

The block of houses known as the White Bear, at the coener of Cheapside and Bread Street, was part of the property of the Hospital of St. James reserved to Eton College when the exchange of 1531 with the Crown took place (see Hospital of St. James no. 10). It can be traced back in these records at least to the thirteenth century (Hosp. of St. James no.7). At least three times in its history has the site been devastated by fire, 1287, 1666 and 1940-1. The first of these fires is recorded in a grant, which survives here in a not too legible transcript (no.52) made in 1773 by the bursat, Edward Betham. Where, one wonders, is the document from which he made this transcript? For it does not appear to be at Eton.

The White Bear which was burned down in 1666 is of the greatest interest, for the house at the southern end of the block was occupied by Milton's father. A good deal is known about the poet's life. Yet the site of the house in which he was born, on 9 Dec. 1608, has never been determined. Aubrey tells us that he was born at the Spread Eagle in Bread Street in the city of London, which was his father's But modern scholarship has not been able to substantiste this statement. A Black Spread Eagle Court appears on maps of a later date than the Great Fire. It was at the north-east end of Bread Street. It was the first court yard on the east side of Bread Street after the White Bear, which was the block of houses at the corner of Bread Street and Cheapside. But the name has not been found for the period before the Great Fire, and it has been thought that Milton's house was further down the street1. It is now possible to vindicate Aubrey and to establish, beyond doubt, the place of the poet's birth. He was born in the White Bear in that part of it which abutted on what was known, at the time

Aubrey made his note, as Black Spread Eagle Court. It is possible also to give a precise description of the house in which, says Aubrey, Milton "when he was very young studied very hard, and sate up very late, commonly till 12 or one a clock at night, and his father ordered the mayde to sitt up for him."

Among the records here catalogued is a plan (no.44) of the <u>White Bear</u>, with a detailed survey (no.42) made on 16
October 1617 by Mr. Thomas Wever, Vice-Provost, and Mr.
Daniel Collins, one of the fellows. The survey was taken on the occasion of the granting of a lease, signed, sealed and delivered the following March, to Sir Baptist Hicks, later Viscount Campden, a rich mercer and moneylender, who already held the right and interest of the previous lessee. His principal tenant, occupying the house at the southern end of the block, was Milton's father.

The elder Milton was by profession a scrivener, whose functions were partly those of a notary or drawer up of documents, and partly those of a broker. He was also a musician and had an organ and other instruments in his house. Aubrey tells us that he had a "plentiful estate" and here again our evidence bears out Aubrey. The size of the house shows a very fair degree of prosperity. It consisted of cellars, a ground floor and four storeys. There were two cellars, one measuring 35 feet 6 ins. by 18 feet 6 ins, the other 17 by 9 feet, both 9 feet high. On the ground floor Milton had his shop, 16 feet 6 ins by 8 feet 8 ins, height On the first floor, here reproduced, and 8 feet 2 ins. called the "Second storie", was "Mr. Milton's Hall", 21 by 20 feet, height 8 feet 10 ins, "wenscotted", "to wen adjoyneth a little Butterie", 11 feet 3 ins by 5 feet 3 ins, and beyond that, at the corner of Black Spread Eagle Court and Bread Street, the parlour, also wainscotted, 17 feet 9 ins

by 13 feet 4 ins, and next to the parlour, on <u>Bread Street</u>, the kitchen, 17 feet 6 ins by 11 feet 6 ins. On the second floor were two large rooms over the hall and the kitchen, 9 feet high, and a little buttery and a small "lodging chamber". On the third floor were "the new chamber over ye hall chamber", 20 feet by 15 feet 6 ins, wainscotted, and "the chamber over ye parler chamber", 25 feet 5 ins by 17 feet 3 ins, height 7 feet. Above that was "the garrett over the new chamber", covering the same area and 7 feet high.

making of the survey. Already his precocious love of study must have shown itself, evidently encouraged from the first by his father, who, he tells us in his eulogy of that admirable parent, never tried to force him into the uncongenial business of the law. Already, no doubt, he was burning the midnight oil adding French, Italian and Hebrew, to his Latin and Greek. In which room, one wonders, did he sit? And in which room did the maid sit and wait up for him?

Twice since Milton lived here has <u>Bread Street</u> been levelled to the ground by fire. As you walk up it today, you have a broad view of devastation on all sides, until you come to the north east corner, where the charred and gutted shell of a building stands on the site of the <u>White Bear</u>. Here is the place. There can be no doubt about it. For the line of <u>Bread Street</u> remains unchanged, though fires may lay low the shops,

"And leave her dolorous mensions to the peering day".

Bethem must have been a dull dog, to have known about this plan (he has endorsed it) but never to have brought

it to light. Henry Maxwell Lyte, at the time he made his catalogue of Library drawer B.16 (Hist: MSS. Comm<sup>r</sup> 9th Rep. (1883) part 1, p. 353), would certainly not have left it at the bottom of the drawer, had his investigations reached the bottom of the drawer.

Chalcots

The Chalcots estate was part of the property of the Hospital of St. James reserved to Eton College when the exchange of 1531 with the Crown took place (see Hospital of St. James, no. 10). The principal interest of the records at Eton relating thereto comes from the information they provide concerning the building that took place at Hampstead in the nineteenth century. But so numerous are the building leases, and other relevant documents, that I have made no attempt to include them in this catalogue.

By an Act of Parliament of 1826 the Provost and College were enabled to grant building leases of lands in the parishes of Hampstead and Marylebone. A prospectus, dated 1 May 1829, which includes a ground plan of the estate, sets out the proposals to let the land on 99 year leases, subject to building covenants, for the erection of substantial and respectable private houses and offices, the plans of which must be submitted to the College surveyor. The surveyor wit this time was John Shaw, the architect, who was succeeded on his death in 1832 by his son, John Shaw (see Dictionary of National Biography); who in his turn (he died in 1870) was succeeded by George Pownall. Far the largest number of the earlier building leases was given to one Samuel Cuming, but the credit for the stylish lay-out and construction of the building of the forties and fifties (Eton Villas, Provost Road) evidently goes to John Shaw, junior, in whose office at Christ's Hospital the elevations of the proposed houses were drawn on the lesses. Grant in mortmain to William Westbury, Provost of the College of St. Mary, Eton, and the College, of two parts of a Crane and Wharf and of the lands in the ward of Vintry, London, which Deryk Pyle held for life, to hold from Michaelmas last for the life of Deryk; the letters of Deryk having been annulled by an act of resumption in the parliament held in Westminster on 6 November 28 Henry VI (1449), whereafter the King by letters patent dated 15 November last committed to the Provost the keeping of the premises from Michaelmas 28 Henry VI, so long as they remained in the King's hands, at the rent of 100s, which letters the Provost has now surrendered; pursuant to a grant to the Provost and scholars of the reversion of the premises after the death of Deryk and of the reversion of the third part thereof after the death of Jacquetta, late the wife of the duke of Bedford, in frank almoin, by letters patent dated 9 April 84 Henry VI (1446)

Jacquette, or Jacqueline, the widow of the Duke of Bedford, married as her second husband Richard Woodville, 1st earl Rivers, who died in 1469. She survived him, not dying till 1472, having become Edward IV's mother-in-law in 1464. The Woodvilles appear to have outsted the Provost and College from their holding in the Vintry, and it was not till the reign of Henry VII that they recovered it (no. 3).

Exemplification, at the request of Henry Bost, Provost, and Inspeximus of a record on the Lord Treasurer's Remembrancer's Memoranda Roll Michaelmas 3 Henry VII rot. 13 (1487), to the effect that it appears on the Pipe Roll of 3 Richard III (London, Middlesex) that the Crown must be acquitted from the issues of two parts of crane and wharf and of lands and tenements in the ward of Vintry which Nicholas Sharp lately had to farm, after the death of master William Hobbys, the King's chirurgeon. By an Act of Resumption in Parliament of 12 February 1468 the said two parts belonged to the Crown from Easter of that year. The Barons of the Exchequer wishing to be informed who had occupied the premises since that date, a writ was sent to the sheriffs of London and Middlesex dated 9 July 1484 to make an inquisition before

the following Michaelmas, which inquisition was taken in the Guildhall on 9 September 1484 and states, inter slia, that between Easter 1468 and 26 June 1483 Anthony Wydevile, late earl of Ryvers, occupied the premises, and from that date until the taking of the inquisition Thomas Howarde, earl of Surrey, occupied the same, and their annual value was 23:4d. And on the day of the taking of the said inquisition the sheriffs took the same into the hands of the Crown by virtue of the said writ. Now in the octaves of Michaelmas of the present term Henry Bost, Provost of Eton, and the College, by Robert Castell their attorney, have come and complain that the premises have been unjustly taken into the hands of the Crown, for they say that Edward IV by Letters Patent of 11 March 1475, which they produce in court, granted the same in frankalmoign to William Westbury then Provost (Letters Patent are recited). The Provost and College say that they enjoyed the same from the date of the said Patent until 9 September 1484 when the sheriffs, Thomas Breteyn and Richard Chester took the same into the hands of the Crown. The premises are described in the Letters Patent as due partes placee wharve domus cum suis pertinenciis proficuis commoditatibus situatis et jacentibus in parochia Sancti Martini in le Vinitrie and they say that these are the same as the due partes crane et wharfe ac terrarum et tenementorum in Warda Vinitrie cum pertinenciis appearing on the Pipe Roll. They say further that the Act of Resumption of 7 November 1485 does not extend to ecclesiastical persons or to any lands granted by Edward IV. They say further that the premises were granted to the Provost and College by Letters Patent of Henry VI dated 30 April 1455 (recited), which they produce. A day is given them at Hillary, then at Easter, when James Hubart, the King's attorney, came and acknowledged that the lands mentioned in the Letters Patent

and those on the Pipe Roll were identical and the Barons ordered that the same should be restored to the Provost and College and restitution made of the issues there had been during the time they had been in the hands of the Crown.

Nos. 1, 2, 3 and 6 of these Miscellaneous documents relate to property which the College does not appear ever to have owned. The presence of no. 3, which concerns tenements of the Hospital of St. James is easily explained. It is possible that the tenements in St. Lawrence Jewry (1, 2) also belonged to the Hospital.

The Patent of 3 February 1453 (no. 4) granting the College a rent from the tenement called "le Lambe" or "le Lombe" in Distaff Lane does not appear to have been enrolled. There are no other documents here relating to the premises 1 and the College interest in the same was certainly shortlived. Foreword

The alien priory of Ellingham in the county of Hampshire formed part of Henry VI's original endowment of Eton College in 1441. It had belonged to the abbey of St. Sauveur le Vicomte in the Cotentin and various documents relating to it are printed in Round's Calendar of Documents in France. But the dated charter there printed (no.979) by which William de Soleriis granted the church of St. Mary of Ellingham to the abbey of St. Sauveur in 1160 will be observed to be different in certain respects from his charter numbered 1 in the present volume. The acreage is different, the witnesses are different, the Eton charter is undated, and the dedications of the church do not tally. The charter of William de Solariis, of which the original is at Eton is recited in the Register of John de Pontissara, bishop of Winchester (Canterbury & York Soc. vol. XXX p. 411, where this charter is dated 1163). In the English document the church is described as "the church of All Saints with the chapel of St. Mery." In the next document (no.2) it is described as "of All Saints", but thereafter it is always "St. Mary's". Perhaps the dedication to St. Mary was adopted on the building of a new church on the land which Hugh de Gernety gave (no.4).

Nos. 1 - 10 are probably all well within the twelfth century in date. These first ten documents all have "sci" written at the bottom in a hand that may not be much later than they are. A possible interpretation of this abbreviated word is that these charters had been "written", or were to be written, to form a cartulary, but no such certulary survives at Eton.

The later records give evidence, as the Eton records so often do, of the poverty of the country parson in the seventeenth (no.67) and eighteenth (no.80) centuries and of the College attitude to this state of affairs (no.81).

Inspeximus by G. (Guy 1241 - 1260) bishop of Bayeax and four abbots of the diocese of Coutances of an agreement between William son of John de Herpetru and the abbey of St. Sauveur le Vicomte in the Cotentin by which the said William, for the souls of his ancestors and the salvation of himself, his wife Matilda, and their children, granted the said abbey the church of St. Margaret of Babbitona, and a virgate of land which Ernaldus the doctor held, and from his wood daily for the brothers dwelling there for their hearth a bundle of whatever wood they like save oak, and twenty pigs without pannage, and the tithe of his house wherever he or his lady shall be dwelling on his lands, of bread whether in corn or bread, of cheeses which they shall eat, of all provisions whether cooked or raw and of beer brewed in his house. The latter, to wit, so long as he shall have it of his own. And when he shall happen to buy (?) he has granted the tenth penny (except drink) and all the oblation of his house as long as he stays in Babbiton. The abbey is to send there a monk priest and a secular priest, acceptable to god and the lord of the province, who, if they are acceptable, are not to be removed without the assent of both. The agreement is such that if the said place can support more than one monk another is to be sent from the abbey. Let none presume to take away the relics which are in the church of St. Margaret, viz. a rib of the said Virgin (St. Margaret) and a rib of St. Blaise and a shoulder blade of St. Cecilia, and the ornaments of the church, viz. a silver chalice and two albs and three amices and one chasuble which are there, and all things which in addition are given to the said place. The place shall give the abbey only one mark silver yearly.

The Colledge reapes all the other profits of corn and hay and gleab, the meanes belonging to the Viccar being so verry small, the viccaridg house is like to fall down, the minister and his family not able to subsist, the publick worship of God is like to be omitted there and the people to want the office and comfort of a minister; unlesse your Majestie vouchsafe to commande that out of the tythe corn and hay which the parishioners yearely pay to the said Colledge som competent part thereof may be yearely allowed to the present minister for the maintenance of himselfe his wife and family.

Therefore we the parishioners, whose names are subscribed, with the rest freely consenting with us do most humbly beseech your Sacred Majesty, that like as you have most piously ordered that out of impropriations the Viccars shall have competent allowance that themselves and families may comfortably live, we do most humbly beseech

your Majesty that out of the tythe corn and hay we do yearely pay, and have this yeare payed, there may be allowed and given to our present minister and to his successors such a liberall mainetenance as your Majesty shall think requisit.

Foreword

The documents catalogued in this volume relate to lands in Stratfield Saye and Stratfield Mortimer which were included in Henry VI's grant to Eton College of 1444 (Parliament Rolls V 81a). A rent from the lands in Stratfield Says had already appeared in the Patent of 1441, and Stratfield Saye also was confirmed to the College in Edward IV's Patent of 23 February 1462. The hermitage of St. Leonard at Stratfield Saye was founded, as these documents show (nos. 1, 2, 7), by William de Stutevill, who is presumably to be identified with the William, son of Nicholas de Stutevill, senior, whose grant of a mark in Estrafled is included in Henry II's confirmation of the endowment of the abbey of St. Mary of Valemont (Neustria Pia p. 871). The hermitage became an alien priory belonging to the Norman abbey, and its early deeds are as rich as any in the Eton collection.

fortunate in its archives, though the church there may have been granted to the abbey of St. Victor en Caux at least as early as St. Leonard to Valemont. For this grant reference must be made to Ston College Records vol. IV, Hullavington, no. 1, where there is catalogued a 14th or 15th. century transcript of a deed of Hugh de Mortimer, granting to the abbey of St. Victor, inter alist the church of "Stratfella" with lands appurtaining.

This Hugh is probably to be identified with that Hugh de Mortimer who died about 1180 (Complete Peerage vol. IX p. 270). Deed no. 99 must be presumed to be a later copy. The property was administered by the prior of Clatford, who was the abbey's proctor general in England.

Notification by William de Stutevill to Jocelin, bishop of Selisbury (1142-1184), and all the faithful, that he has granted in frankalmoign to Godard, the recluse, and his successors the hermitage of St. Leonard on the Loddon with all its appurtenances, together with firewood and hedging and quittance from pannage. And ratification of any future grants to the same or of whatever the grantee or his successors may acquire by the grace of god or by their industry. The land of St. Leonard is as follows:-from the water of the Loddon to the outer corner of the land which was of Yolfus and thence to the boundary of Sceprige from below the mere, and from the outer corner of the land of Yolfus below the road to the bank by his frith and the meadow in the corner of the frith.

And further, grant of a virgate of land at Stretfeld which Adam Pohca held, that two masses may be celebrated there each week, one for the souls of his parents and ancestors and the other for the salvation of himself and his (heirs), Saving the benefit of the church of Strafeld from the said virgate and from the acres which his men have given or will give. Turchetil for his part has given the said hermitage two acres which lie in Erthelonde. Alexander has given three acres in Puriforlang next Chielder and half an acre which is called Woghenelve and half the island which he had under Haiwud. Richard the Butler has given two acres in Vueworthe, William Nuthec one acre Alangethorne.
