SUNDERLAND
George Hudson's Charity

Hudson, of The Grange, Monkwearmouth, bequeathed the residue of his estate after his death (which occurred in 1884) for the education, maintenance, support and clothing of boys and girls aged 8-14 who were fatherless. Priority was given to the sons of sailors or pilots from the Port of Sunderland, and boys born and resident in the Parish of Monkwearmouth. No part of the money was to be used to buy land or provide buildings. Total funds received by the Trustees eventually totalled over £167,000.
